MATTER DETERMINED

2016SNH002 - Ryde - LDA2016/0552 at 192 Balaclava Road Macquarie Park (AS DESCRIBED IN SCHEDULE 1)

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

REASONS FOR THE DECISION

The Panel considered the Council Assessment Report and accepted the recommendation.

The proposal is consistent with the approved Concept Plan for the University and provides additional research and administration accommodation as well as landscaping.

The Panel considered the concerns of the objectors and found that:

- The university has confirmed that no dangerous goods will be stored within the building;
- There will be removal of 44 trees of variable condition, however replacement planting is to be provided at the ratio of 2:1 with locally endemic species which will result in increased tree canopy and support ecological communities;
- The proposal will accommodate an additional 15 staff. Parking is provided elsewhere on the university and public parking is available on Culloden Road. The University has indicated that it will provide additional car parking and there are plans to improve public transport and pedestrian and cycle ways on site.

CONDITIONS

The development application was approved subject to the conditions in the Council Assessment Report.
