DECLARATIONS OF INTEREST	Ian Scandrett declared a non-pecuniary and non-significant interest in the application as he had previously considered as a Councillor a section 96(1)(a) application for the same matter in October 2016 where Council did not support the application (conflict of duties).

Public meeting held at Wingecarribee Shire Council, Civic Centre, 68 Elizabeth St Moss Vale on Friday, 17 March 2017, opened at 12pm and closed at 1pm.

MATTER DETERMINED

2016STH030 - 15/0146 - 67 Elizabeth Street, Moss Vale Moss Vale Police Station (AS DESCRIBED IN SCHEDULE 1)

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to recommend to the Minister to:

- Approve modification to Development Consent 15/0146 to allow for addition of a substation with a new wall and signage
- Refuse modification to Development Consent 15/0146 to delete Condition 53 requiring payment of \$109,449.79 contributions under Council's Section 94 Contributions Plan

The Panel made its determination with reference to approve the development application as described in Schedule 1 pursuant to section 89 and 96 of the *Environmental Planning and Assessment Act 1979*. The decision was unanimous.

REASONS FOR THE DECISION

The reasons for the decision of the Panel were:

- The Panel was satisfied that the proposed modifications are of minimal environmental impact and that the development as modified is substantially the same as the development to which the consent was originally granted
- The application has been notified with nil submissions received
- The application does not raise any additional relevant issues under S79C
- The arguments provided in support of deletion of Condition 53 are generic and do not adequately justify why the contribution should be waived.

CONDITIONS

Deletion of the condition from the DA for a section 94A condition is not supported as the argument provided by the Police are generic and do not adequately justify why the contribution should be waived.
