## PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*. The decision was unanimous.

#### **REASONS FOR THE DECISION**

The reasons for the decision of the Panel were:

- The site has the appropriate zoning.
- The proposal is permissible under BLEP 2015 and BDCP 2015.
- The development is satisfactory with regard to all required statutory considerations and environmental planning instruments (including in particular s. 79C of the Environmental Planning and Assessment Act 1979).
- The applicant's independent traffic report, Noise and Vibration Impact Report and Geotechnical and Environmental Investigation Report are satisfactory and have been accepted by Council subject to conditions accepted by the applicant.
- The development will provide a public benefit, in providing suitable parking for staff, visitors and patients for Blacktown Hospital and will not have any unacceptable adverse impacts on the natural or built environment.

The development application was approved subject to the conditions in the Council Assessment Report.
