There are a number of areas within this building that due to the nature of the activities undertaken it is inappropriate to provide accessible access due to the particular purpose for which the area is used as the functions undertaken in the areas could pose a safety risk for people with a disability. Such areas include plant rooms.

f) Adaptable Housing – AS4299 Class C

Ten (10) units in this development have been nominated and designated as adaptable dwellings.

The replacement of the kitchens and bathrooms method of adaption has been adopted as per the provisions of AS4299.

Plans indicating pre and post adaption unit configurations have been prepared by PTW Architects as part of the Development Application process.

The internal walls are lightweight plasterboard enabling the repositioning of GPO points and other switches as required by the incoming resident.

The specific needs of the incoming residents of these apartments is unknown. Any adaption of the dwelling will be specific to the needs of the residents.

We will require certification from the builder that the required wall strengthening of the nominated accessible bathroom walls has been installed to meet the requirements of AS4299.
