1. As per DPI ALUP previous correspondence on this development (Ref: OUT16/37643), the EIS dated 26/7/16 does not provide enough information to assess the proposed extraction of 490,000 tonnes from this site. It is not even clear if there is this amount of resource available.

2. With regard the compliant provided on 30/11/16, DPI would also be concerned about the matters included, environmental management and aboriginal heritage management, based on the above comment. However the Office of Environment and Heritage would be best placed to provide appropriate advice on these matters.
