Thank you for your letter dated 29 November 2016 referring DA2016/413 to Roads and Maritime Services for comment. Roads and Maritime notes the proposal is for a resource recovery facility that will process up to 30,000 tonnes per annum of principally concrete and masonry products.

The documentation submitted in support of the proposed development has been reviewed. Roads and Maritime does not object to the proposed development and, in accordance with clause 77 of the *Environmental Planning and Assessment Regulation 2000*, makes the following comment for Council's information:

- The installation of a 'give-way' sign at the intersection of Lyall and Russell Streets, recommended in section 6.2 of Appendix K, requires the prior approval of Bathurst Regional Council following consideration of the recommendation by the Bathurst Local Traffic Committee.
