Good Morning William

The Department has reviewed the conditions and has only raised an issued with one item – Condition 28 Construction Work Times. As previously discussed, we have some in-ground remediation works, which has to occur at construction commencement. The expected time frame for the remediation is approximately 4 days. The Department requires these works to occur outside of normal school hours and the only available time prior to the 2018 charismas holidays are Saturdays. Only permitting work between 8am – 1 pm will add an additional month to the program, which increases the period of disruption to the school. The preference is to complete these works as soon as practicable to limit the impact on the school and surrounding neighbourhood.

Therefore, the Department is requesting an extension of work times on a Saturday – 8am -4 pm but only applied to the 4 days for the remediation works at the beginning of construction period. The 8am – 1pm restrictions will apply for all other construction activities.
