DECLARATIONS OF INTEREST	George Cecato declared a non-significant interest as he operates a Thrifty Car Hire franchise which rents cars on contract to some of the teams that use the stadium. The contracts are negotiated by Thrifty Head Office and the upgrade on the facilities will not have an impact on those contracts.

2017NTH022 – Coffs Harbour – 0230/18 at Lot 102 DP 1077682, Stadium Drive, Coffs Harbour (AS DESCRIBED IN SCHEDULE 1)

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings listed at item 8 in Schedule 1.

The Panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

The reasons for the decision of the Panel were:

- The proposed development is permissible under the Coffs Harbour LEP 2013;
- The proposal does not involve a change of use of the land nor does it increase the level of patron capacity;
- The proposed development is not expected to result in any flooding impacts;
- The site is located within the 48.06 contour on the Obstacle Limitations Map, however as the proposed development is less than 7 metres in height it does not penetrate the Obstacle Limitations Surface;
- The construction phase of the proposed development is expected to result in some disturbance in the locality, however appropriate conditions are proposed to limit hours of construction, management of dust impacts and installation of erosion and sediment control measures.

CONDITIONS

The development application was approved subject to the conditions in the Council Assessment Report with the change in condition 5 to refer to the "Northern Annex" rather than the "Northern Annexure".
