2017SCL064 - Bayside - DA 2017/1198 AT 1-3 and 3A Ricketty Street Mascot (AS DESCRIBED SCHEDULE 1)

## PANEL CONSIDERATION AND REASONS FOR DEFERRAL

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to defer the development application as described in Schedule 1 pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The Panel deferred the determination of the application to resolve the wording of the condition relating to the easement for pedestrian and bike access along the foreshore. The Panel noted that the Draft Condition 127 seeking a 10 metre strip of the site along the foreshore to be dedicated is unlawful and should be deleted. Both the council and applicant should liaise to satisfactorily resolve the terms of a condition to allow for appropriate public access. This should be resolved by the 12 April 2018.

The supplementary report shall be prepared by Council and submitted to the Panel by 19 April 2018.

When the supplementary report has been received, the Panel will determine the matter electronically, unless the Chair considers that a public meeting is necessary.

The Panel adjourned during the meeting to deliberate on the matter and formulate a resolution.

The decision was unanimous.
