## MATTER DETERMINED

2017SNH021 – Hornsby – DA129/2017 at 38-76 Palmerston Road Hornsby (AS DESCRIBED IN SCHEDULE 1)

### PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

### **REASONS FOR THE DECISION**

The reasons for the decision of the Panel were:

The proposal is satisfactory in respect of Hornsby Local Environmental Plan 2013, SEPP 55 Remediation of Land, SEPP Infrastructure 2008 and Hornsby DCP 2013.

The proposal provides much needed car parking for the expanding hospital and will lead to a reduction of street parking. The impacts are considered acceptable.

Two submissions were received, one in support of the additional car parking. The other, which was tabled at the meeting, opposed the location of car parking entry / exit points opposite their property. Council assessment staff had undertaken a site inspection and advised that the design of the residence itself (with double garage on the street and one single window facing the car park but set back from the street) would reduce the impact of light spill. Moreover, it was not possible to identify a better solution for **all** residents of the street.

#### CONDITIONS

The development application was approved subject to the conditions in the Council Assessment Report.
