MATTER DETERMINED

2017SNH060 – Northern Beaches – DA2017/0711 at 11 Tilley Lane Frenchs Forest (AS DESCRIBED IN SCHEDULE 1)

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the development application as described in Schedule 1 pursuant to section 80 of the *Environmental Planning and Assessment Act 1979*.

The Panel adjourned during the meeting to deliberate on the matter and formulate a resolution.

The decision was unanimous.

REASONS FOR THE DECISION

The reasons for the decision of the Panel were:

- The proposal complies with the principal planning controls, except for a minor non-compliance with the site coverage and, consequently, with the landscaped area control. The variation of the western setback is also minor and generally consistent with other nearby development.
- The proposal provides medical services close to a major hospital.
- The Panel considered the objection of the neighbour to the north, which related mainly to loss of view. However, the Panel concluded that this did not justify refusal of the application, given that there is no height limit on the site and the loss of view was from offices. In addition, the Panel noted that the application includes the planting of four Angophora costata trees in the northern setback to reduce the visual impact. With regard to the concern about noise from operating plant, the Panel is satisfied that this will be adequately managed by the location and containment of the plant on the roof. With regard to the concern about parking, the Panel notes that the proposal provides parking in excess of that required.

CONDITIONS

The development application was approved subject to the conditions in the Council Assessment Report.
