Thank you for your response.

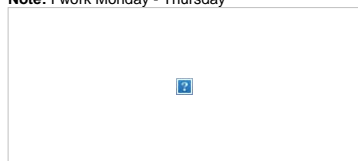

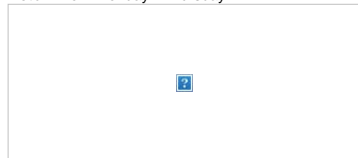
