The decision was unanimous.





REASONS FOR THE DECISION

The Panel determines the application by granting consent for the following reasons:

1. The proposal will provide sought-after recreational and sporting facilities in an accessible and convenient location. It will facilitate greater access to the waterway for both formal rowing crews and informal voting by individuals or couples.
2. The proposal will enhance the foreshore by providing a well-designed, interesting and attractive new facility.
3. The proposal is consistent with the concept approval for development on this site and complies with all applicable standards and guidelines.
4. The proposal has all necessary supporting infrastructure and will not burden local services. With the conditions imposed the development will have no material adverse impacts on the built or natural environment.
5. For the reasons given above, approval of the application is in the public interest.

CONDITIONS

The development application was approved subject to the conditions supplied by Council on 29 May 2018 and as amended agreed with the applicant during the course of the meeting.
