MATTER DETERMINED

Panel Ref – 2017SWC135 - LGA – Cumberland, DA-2014/616/2, Address – Lot 4012, Driftway Drive, Pemulwuy (AS DESCRIBED IN SCHEDULE 1)

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meeting and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the application as described in Schedule 1 subject to the recommended conditions pursuant to sections 96(2) & 80 of the Environmental Planning and Assessment Act 1979.

REASONS FOR THE DECISION

- 1. The Panel considers the proposal to be substantially the same development as that approved by the Sydney West Joint Regional Planning Panel (JRPP) on 16 March 2016.
- 2. Deletion from the application of the proposed subdivision of the subject land overcomes the concerns raised previously by the Joint Regional Planning Panel and Cumberland Independent Hearing and Assessment Panel.
- 3. Each stage of the proposal complies fully with the applicable planning controls including the Holroyd LEP 2013 and Holroyd DCP 2013.
- 4. Staging of construction works will allow orderly and economic development of the land which is zoned for high density residential development.
- 5. In consideration of conclusions 1-4 above the Panel considers the proposed development is a suitable use of the site and approval of the proposal is in the public interest.

The decision was unanimous.

The development application was approved subject to the conditions in the Council Assessment Report.
