Please find attached vehicle characteristics for the small garbage truck. The garbage truck has a wheel base of 2.8 m and a kerb to kerb turning circle of 10.4 m diameter. The swept paths for the Australian standard small rigid vehicle (SRV) prepared in our drawing 16077-CI-020 rev 3 is attached. The AS2890.2 SRV has a wheel base of 3.8 m and a turning circle diameter of 14.2 m. The SRV has a much greater turning circle than the small garbage truck and the small garbage truck will be able to be driven within the allocated space for the SRV.
