VEHICULAR ACCESS FOR WASTE COLLECTION TRUCKS 144-146 BORONIA ROAD, GREENACRE PROPOSED BOARDING HOUSE DEVELOPMENT

I refer to the issues raised by Council in regard to vehicular access for waste collection trucks into the basement of the proposed boarding house development at 144-146 Boronia Road, Greenacre, for the amended basement layout plan attached to this statement (Plans No. A1-09 and A1-10, Issue E, dated 23/11/2018 and prepared by CK Design.

We reviewed the above mentioned plans and confirm they are adequate for vehicular access by a Small Rigid Vehicle (SRV 6.4 metres in length), where the SRV can enter and exit the site in a forward direction. Refer to the vehicle swept paths for SRV, attached to this statement and illustrating forward entry and exit and manoeuvring within the basement level.

Refer also to the attached letter from Waste Wise Environmental dated 25 March 2019, which confirms that they can supply ongoing waste and recycling services upon completing of the subject development. The letter confirms that their 'Waste Bin Mini' vehicle rear loader with the following dimensions (height 2.08m, length 6.4m and width 1.7m) will enter and exit the basement in a forward direction.

This statement confirms that the attached amended basement level layout is considered to be satisfactory and in accordance with the requirements of AS2890.1:2004, AS2890.6:2009 and AS2890.2:2002, with an adequate headroom clearance of 3.5 metres for a Small Rigid Vehicle.

Dear Chris, I have viewed your plans and swept paths for the above site and I can confirm that WASTEWISE are able to supply ongoing waste and recycling services upon completion of this development.

Residential Waste & Recycling collection:

- General Waste and Commingled Recycling will be deposited by residents and or caretakers in accessible
 waste storage room in basement
- Waste Streams will be stored separately in 660 Litre Mobile Garbage Bins. Utilising 660 Litre Mobile Garbage Bins, will minimise the service time and total number of bins on site.
- The Waste Wise MINI rear loader (height 2.08m, length 6.4m and width of 1.7m) will enter the
 basement from Boronia Road in a forward motion and stop in the designated area to service the bins in
 a safe and timely manner as per site requirements. On completion the vehicle will proceed to exit on to
 Boronia Road in a forward motion, turning left.
- By utilising 660 Litre Mobile Garbage Bins we ensure that the bin is only ever raised to the same height
 as the truck.
- General Waste will be serviced twice per week or as often as required.
- WWE will endeavour to transport General Waste to the nearest and best suited licensed disposal
 facility. In this vicinity there are several options including SUEZ Resource Recovery Auburn, Rockdale
 Resource Recovery centre and Banksmeadow Transfer Terminal.
- Commingled Recycling will be serviced once per week or as often as required.
- WWE will endeavour to transport General Waste to the nearest and best suited licensed disposal
 facility. In this vicinity there are several options including VISY Recycling centre St Peters, VISY Recycling
 centre Smithfield and WASTEFREE Recycling at Seven Hills.
- General Waste bins will be green with a Red Lid
- Recycling bins will be green with a yellow Lid
- · Separated waste streams will be serviced on different days.

Posters will be displayed in notice areas and above every general waste and commingle bin in the Bin Room to ensure residents understand what waste stream goes into which colour coded bin.

Waste Wise Environmental staff will attend site meetings as required to ensure and promote the waste system and encourage recycling outcomes.

Fitted with reverse camera to the driver's cabin






