The Panel will meet to determine the following:

2018SWC016 - City of Parramatta - DA/1025/2017:

659 Victoria Road, Melrose Park

Description - Stage 2 detailed application (south-east corner of site) of approved concept plan DA/1157/2016 comprising earthworks, excavation of 3 basement levels providing 281 car parking spaces, construction of 3×7 -9 storey residential flat buildings containing 234 residential apartments, strata subdivision, landscaping, new internal roads, public domain works, and Torrens title subdivision.

2018SWC005 - City of Parramatta - DA 1042/2017:

657-659 Victoria Road, Melrose Park

Description - Stage 3 detailed application (western side of site) of approved concept plan DA/1157/2016 comprising earthworks, excavation of 3 basement levels providing 181 car parking spaces, construction of 2 x 7-10 storey residential flat buildings containing 157 residential apartments, strata subdivision, landscaping, new internal roads, public domain works, and Torrens title subdivision. The application is Integrated Development under s138 of the *Roads Act* 1993.

• 2018SWC093 - City of Parramatta - DA1157/2016/A:

657-659 Victoria Road, Melrose Park

Description - Section 4.55(2) modification to approved concept plan for 4 stage mixed use development, including increase in number of proposed dwellings from 1,077 to 1,126 (49 additional dwellings), modification to building envelope heights and footprints, realignment of superlot boundaries and street network and revised subdivision plan.

• 2017SWC139 - City of Parramatta - DA171/2014:

12-14 Phillip Street & 331A-339 Church Street, Parramatta

Section 4.55(2) modification to approved mixed-use tower development including, but not limited to, 3 additional residential storeys, 66 additional basement car parking spaces, reconfiguration of podium, revised residential unit mix and revised stratum subdivision. The original application was Nominated Integrated Development under the *Water Management Act 2000* and the *Fisheries Management Act 1994*.

69 George Street, Parramatta (Roxy Theatre)

Description – A concept development application in accordance with Section 4.22 of the RP&A Act 1979 to establish the building envelope, land uses and key site planning elements.

44-48 Oxford St, Epping

Demolition of all existing structures including the heritage listed dwelling on site, tree removal, construction of a mixed use development in the form of 2 towers (15 and 18 storeys tall) over a podium and basement car parking.
