KEY ISSUES DISCUSSED AND MATTERS TO BE ADDRESSED IN THE COUNCIL ASSESSMENT REPORT:

This matter came before the Panel for a briefing from the council which the applicant was allowed to attend. The meeting took place on Wed 31 July as the matter is on appeal and the first court appearance is Tuesday 6 August. On the previous attendance before the Panel, the Panel sought certain matters to be addressed, namely:

- Use and ownership of the laneway
- Traffic impacts
- Non-compliance with LEP/DCP
- Loss of commercial space
- Through site link
- Wheelchair access
- Wind conditions in Rawson Street
- Vehicular access
- Concerns raised by the community

with amended plans or additional reports to be brought back to the Panel. The date scheduled for the Panel meeting was 7 August and Council advised it was unable to finalise its report for the Panel until Wed 31 July.

It is noted that the Council's assessment report is now available on the Panel website.

At the meeting the Council advised on the following matters:

- Through site link provided but still unsatisfactory:
- Accessibility of concern as stairs still occur in the link and trees planted for wind amelioration purposes within the link are in the way of wheelchair users;
- Wind report not satisfactory to Council's wind expert who uses different assessment criteria to those used by the applicant's expert;
- Amelioration suggested for wind response including screens on the link walkway and hedge planting not acceptable to Council;
- Green travel plan not yet acceptable
 - No offer of Opal card

Only 2 car share spaces and Council wanted 4 spaces

No end of trip facilities provided

Car parking may be excessive

- Floor space calculations not agreed by council;
- Sydney Metro still needs to give concurrence;
- Council still finds the residential entry to be unsatisfactory.

The applicant responded by advising the Council and Panel it believed it could answer all the Council concerns.
