MATTER DETERMINED

2018SWC061 - City of Parramatta – DA/326/2018 at 2B Hill Road, Lidcombe – Construction of three (3A) residential flat buildings over five (5) levels of basement (as described in Schedule 1)

PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

Development application

The panel determined to refuse the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

The Panel determined to refuse the development application for the reasons contained in Attachment B of the Assessment Report.

CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the panel considered written submissions made during public exhibition. The Panel notes that issues of concern included:

- The proposal is out of character;
- Privacy;
- Loss of views;
- Devaluation of nearby properties;
- Traffic impacts;
- Insufficient infrastructure;
- Lack of public transport;
- Loss of peace quiet within the area; inferior quantity of development.

The Panel considers that concerns raised by the community have been adequately addressed in the assessment report and that no new issues requiring assessment were raised during the public meeting.
