Public meeting held at Liverpool City Council Library on 28 June 2019, opened at 3.00pm and closed at 6.27pm.

MATTER DETERMINED

Panel Ref – 2018WCl002 - LGA – Liverpool – DA349/2018 AT 401 Hoxton Park Road, Hinchinbrook (AS DESCRIBED IN SCHEDULE 1)

PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

- 1. The proposed development will improve and modernise the available facilities of the existing school and provide capacity to accommodate additional students.
- 2. The proposed development adequately satisfies the relevant State Legislation and Environmental Planning Policies including the Water Management Act 2000, the Rural Fires Act 1997, SEPP 55 Remediation of Land, SEPP (Educational Establishments and Child Care Facilities) 2017, SEPP (Infrastructure) 2007 and Regional Environmental Plan No. 2 Georges River Catchment. With the regard to SEPP (Educational Establishments and Child Care Facilities) 2017 the Panel accepts that the proposal is consistent with the objectives of the instrument, and in particular notes the assessment report's conclusions that the design meets the Design Quality Principles in Schedule 4.
- 3. The proposal is consistent with relevant provisions of Liverpool LEP 2008 and Liverpool DCP 2008. The Panel notes that while the subject site is flood affected the proposal has been assessed as satisfactory subject to the proposed conditions and that a flood evacuation plan has been prepared. The RFS has indicated its concurrence subject to conditions which have been incorporated into the conditions of consent to the DA.
- 4. The proposed development subject to the conditions imposed will have no unacceptable adverse impacts on the natural or built environments including the amenity of nearby

buildings, the operation of the local road system or the vegetarian located on the subject site.

5. In consideration of these conclusions the Panel considers the proposed development is a suitable use of the site and approval of the proposal is in the public interest.

CONDITIONS

The development application was approved subject to the conditions presented at the meeting on 28 June 2019.

CONSIDERATION OF COMMUNITY VIEWS

There were no community submissions and no person other than representatives of the Applicant presented at the meeting.
