



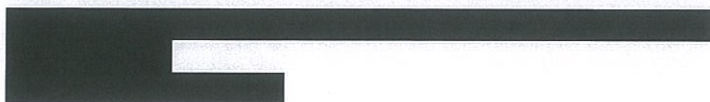

Parkes Shire Council has received a development application from Pacific National (NSW) Pty Ltd for a proposed Freight Transport Facility lodged on 27 March 2018. You may make written submission or objection to the Parkes Shire Council with respect to the proposed development. If your comments are an objection, then the grounds of the objection must be specified.

Any submission you wish to make must be received in writing by Council not later than 5.00pm on the 23 April 2018. All submissions, including any personal information contained therein, will become publicly available documents and will be made available to the applicant and any other interested member of the public. They may also be included in Council's business paper which is a public document and can be accessed from Council's website by members of the public. Copies of Council's business papers are provided to the local newspaper and members of the press.

If you do not wish your submission to be publicly available you must provide Council with written reasons for this. Alternatively you may wish to provide an anonymous submission, however, anonymous submissions may be given less (or no) weight in the overall consideration of the proposal.

IF YOU DO NOT WISH TO MAKE A SUBMISSION TO COUNCIL CONCERNING THIS PROPOSAL, IT IS NOT NECESSARY FOR YOU TO WRITE TO COUNCIL.

The Environmental Planning and Assessment Act 1979 requires the public disclosure of donations or gifts when lodging or commenting on development proposals.

If you have made a political donation within the meaning of the Environmental Planning and Assessment Act and are making a submission in relation to this development you are required by the Act to make a declaration of the donation. A declaration template containing all the required information to be provided by the Act can be obtained from Parkes Shire Council Planning and Environment Department.
