CONTEXT

• The Chair called for a combined briefing due to the connected nature of these two DAs, which function as a large subdivision that covers land in two Local Government Areas (LGAs).

ISSUES DISCUSSED

Overview for briefing, update from last briefing and Panel's role in the briefing.

Applicant briefing

- Site had been identified as residential release area for 12 years, with development commenced on Stages 1 and 2.
- Deemed refusal appeal discontinued in May 2021.
- o Significant studies and work undertaken to support application.
- Response provided to Councils regarding RFIs, noting that some outstanding issues are being finalised.
- o Notation of Panel briefing on 03/08/22 and issues raised in relation to traffic.
- Request for further modelling is not required, and note that consent/concurrence is not required by TfNSW.
- Acknowledgement that upgrade works are required prior to the release of any lot.
- o Grampian style condition proposed as exact intersection details are not required at this stage.
- Application is ready to be reported on.

Transport for NSW (TfNSW)

- Written position provided and background provided.
- Applicant's request to proposed amendments has been considered.
- Additional information required in regard to identify the required works due to modelling deficiencies.
- o Grampian style condition not considered applicable to proposal.
- o Integrated Transport Plan being undertaken by TfNSW.
- Modelling undertaken by other developments may assist with additional information request
- Willingness to work with all parties to activate their lands and to enable functional use of the network.

Newcastle City Council (NCC) overview

- o Previous conditions and transport report from Court appeal not provided to NCC.
- O No assessment undertaken in relation to proposed Grampian condition as proposed works have not been identified through the modelling.
- Assessment being undertaken of information provided noting the utilisation of the February
 2021 report as updated April 2022 report has not been received.
- o Consideration of TfNSW advice in assessment of the application.
- Submission period close with up to 12 submissions being received.
- o Meeting held with applicant, Subsidence Advisory and LMCC written response outstanding
- O Discussion with LMCC to be undertaken in relation to works proposed in LMCC LGA to support NCC application.

Lake Macquarie City Council (LMCC) overview

- o Traffic assessment to consider TfNSW response.
- Unable to complete environmental assessment as all works are yet to be identified.
- Additional information to be requested by Subsidence Advisory, noting offer to provide details prior to Subdivision Works Certificate.
- o Submissions provided on website.
- Earthworks to be discussed further.

O VPA is outstanding – draft being reviewed and requires review by NCC.

GENERAL MATTERS DISCUSSED

- Panel will seek further legal advice re proposed condition.
- Mine subsidence implications need to be considered and assessed.
- Council's assessment of regional traffic impacts will rely on TfNSW advice.
- Environmental assessment will rely on certification, but Panel needs to understand potential impacts and implications arising from changes to policy and statutory framework since certification.

NEXT STEPS

- Additional information in relation to required works and any offsite impacts are to be provided to enable assessment of application.
- Panel to seek advice in relation to proposed Grampian style condition.
- Council be requested to prepare assessment reports.
