Reference is made to your letter of 8 January 2019 requesting comment from Roads and Maritime Services in relation to the proposed modification to extend the haulage route.

The key interests for Roads and Maritime are the safety and efficiency of the road network, traffic management, the integrity of infrastructure and the integration of land use and transport.

In accordance with Clause 16 of the State Environmental Planning Policy (Mining, Petroleum Production and Extractive Industries) 2007, Roads and Maritime is given the opportunity to review and provide comment on the subject development application.

Roads and Maritime has reviewed the referred information and provides the following comments to assist the consent authority in making a determination;

- 1. Roads and Maritime found the information provided to be insufficient to undertake a detailed assessment of the haulage route. Therefore, Council should be satisfied the impacts on the proposed haulage route for through and turning traffic has been adequately addressed.
- 2. There will be adequate sight distances available at key intersections and the swept paths for the largest vehicle have been catered for.
- 3. Consideration should be given to limiting haulage to hourly and daily rates so it is spread across an appropriate time frame.
- 4. It is recommended the Operational Plan of Management should include a Traffic Management Plan (TMP) to manage haulage and driver behaviour along the haulage routes. It should be prepared by an appropriately qualified person in consultation with Council and Roads and Maritime.
- 5. The TMP should include a Code of Conduct that includes but not be limited to:
 - a. A map of the primary haulage routes highlighting critical locations.
 - b. Safety initiatives for haulage through residential areas and/or school zones.
 - c. An induction process for vehicle operators & regular toolbox meetings.
 - d. A complaint resolution and disciplinary procedures.
 - e. Any community consultation measures for peak haulage periods.
