PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

The decision was to defer this matter pending additional information.

The Panel was of the view that the Development Application was not appropriately made. The full DA fees have not been paid to date to enable full consideration of the material lodged and subsequent amended plans. The Panel recommends that the applicant complete payment of the fees so a full and complete assessment of all their documentation and amended documents can be made.

The Panel has determined to refer the matter back to Council for assessment and requires that the applicant lodge the outstanding fees within 7 days of the publication of this hearing. Pending Council feedback, which is be provided within 21 days from the date of payment, any additional material to be prepared and submitted to Council by the applicant is to be received by Council by mid-January 2021. The application needs to be assessed by Council and resubmitted to the Panel no later than March 2021.

If the applicant does not make the payment the application will remain undetermined.

The decision of the Panel was unanimous.
