## **Executive Summary**

#### Background and Primary Objective

Supa 88 Pty Ltd ('the client') engaged EI Australia (EI) to conduct a Preliminary Site Investigation (PSI) of the land parcel located at 22-32 Queen Street, Campbelltown NSW ('the site'). It was understood that this PSI would accompany a demolition application to Campbelltown City Council for demolition of the existing structures.

The primary objective of this PSI was to provide a qualitative assessment of the environmental condition of the site, by appraising the potential for site contamination on the basis of field observations, historical land uses and anecdotal and documentary evidence.

#### Key Findings

The key findings of this PSI were as follows:

- The site (20,465.7m<sup>2</sup>) was comprised of vegetation at 22 Queen Street, one brick storage building at 24 Queen Street and one commercial (factory outlet / parking) complex at 32 Queen Street.
- The site was mostly sealed with buildings and hardstand (concrete) pavements. The remaining (unbuilt) parts were vegetated areas.
- Waste building materials were stockpiled in the south (eastern) parts of the site (at the rears of the two buildings). Fragments of FCS were observed on the ground surface in front of the building on 24 Queen Street (i.e. in northern site corner).
- The site was used for low density, residential and open space purposes up to 1965 (at least). Redevelopment of the site, which included the replacement of residences and vegetation with commercial / industrial buildings and hardstand concrete, commenced sometime between 1965 and 1975. The storage building at 24 Queen Street was likely constructed between 1975 and 1984, while the factory outlet / parking complex at 32 Queen Street was constructed around 2009.
- The commercial activities which took place on the site included joinery manufacture, motor towing services, motor garages and/or service stations (32 Queen Street; 1979-1991), motor dealers, contractors, glass merchants and a bowling centre.
- No visual or olfactory evidence of (gross) contamination was detected on the site.
- During the site walkover, there was no visual evidence that a UST or AST was present on the site. However, the SafeWork NSW search indicated that UPSS was present at 32 Queen Street as a result of former service station activity between 1979 and 1991.
- The site was free of statutory notices and licensing agreements issued under the Contaminated Land Management Act 1997 and Protection of the Environment Operations Act 1997. The site was not included on the List of NSW Contaminated Sites Notified to the EPA.
- There were no registered bores within a 500m radius of the site, indicating that the local groundwater resource was not being (heavily) utilised.
- Potential (off-site) migration of contaminants from neighbouring properties was considered to be low, given that the most likely sources were cross- to down- gradient of the site.
- The CSM established there was low to moderate potential for site contamination derived from the identified sources, except in relation to the hazardous building products, which was considered to pose a high likelihood.



#### Conclusion

Based on the findings of this PSI and with due consideration of EI's Statement of Limitations (**Section 7**), it was concluded there was potential for contamination to exist on the site. Following demolition and prior to any future redevelopment, a detailed (Phase 2) investigation should be undertaken, to further characterise the soils and groundwater at the site and determine the suitability of the land for future proposed use.



## 1. Introduction

### 1.1 Background and Purpose

Supa 88 Pty Ltd ('the client') engaged EI Australia (EI) to conduct a Preliminary Site Investigation (PSI) of the land parcel located at 22-32 Queen Street, Campbelltown NSW ('the site'). It was understood that this PSI would accompany an application to Campbelltown City Council for demolition of the property.

The site is located 41km south-west of the Sydney central business district (CBD), within the local government area (LGA) of Campbelltown City Council, as shown in **Appendix A**, **Figure 1**. It comprises three cadastral allotments, identified as Lot X in Deposited Plan (DP) 409704 (22 Queen Street), Lot 15 in DP 14782 (24 Queen Street) and Lot 1 in DP 1154928 (32 Queen Street), covering a total area of 20,465.7m<sup>2</sup>, as shown on the survey plans attached in **Appendix B**.

At the time of this investigation, the site was occupied by vegetation at 22 Queen Street, one brick storage building at 24 Queen Street and one commercial (factory outlet / parking) complex at 32 Queen Street. The remaining (unbuilt) parts were either concrete paved, or grassed areas.

### 1.2 Proposed Development

It was understood that this assessment is required to accompany a demolition application to Campbelltown City Council for demolition of the existing structures. At the time of this report writing, EI was not provided the future proposed plans for redevelopment of the site.

### 1.3 Regulatory Framework

The following regulatory framework and guidelines were considered during this PSI:

- Contaminated Land Management Act 1997 (the CLM Act 1997);
- Protection of the Environment Operations Act 1997 (the POEO Act 1997);
- State Environmental Planning Policy 55 (SEPP 55) Remediation of Land;
- Campbelltown Local Environmental Plan 2015;
- EPA (2017) Guidelines for the NSW Site Auditor Scheme;
- EPA (2020) Consultants Reporting on Contaminated Land: Contaminated Land Guidelines;
- NEPC (2013) Schedule B(2) Guideline on Site Characterisation.

#### 1.4 Project Objectives

The primary objective of this PSI was to provide a qualitative assessment of the environmental condition of the site, by appraising the potential for site contamination on the basis of field observations, historical land uses and anecdotal and documentary evidence.

A secondary objective was to make recommendations for further investigation of the site, should the potential for contamination be confirmed.



## 1.5 Scope of Works

In order to achieve the above objectives, the following scope of works was completed:

- Review of relevant (hydro)geological and soil landscape maps for the project area;
- A search for groundwater bore records within close vicinity (500m radius) of the site;
- A site walkover inspection;
- Review of site history, based on an environmental risk and planning report compiled by Lotsearch Pty Ltd;
- A search of historical aerial photographs, in order to review previous site use and the historical sequence of land development in the neighbouring area;
- A search of property files archived by Campbelltown City Council, for information relating to operational site history;
- A search of SafeWork NSW records, for information relating to the storage of hazardous chemicals, including possible underground tank approvals and locations;
- Searches of public registers maintained by the NSW Environment Protection Authority (EPA) for statutory notices and licensing agreements issued under the *Contaminated Land Management Act 1997* and *Protection of the Environment Operations Act 1997*;
- A search of the List of NSW Contaminated Sites Notified to the EPA; and
- Reporting.

This PSI report was completed in accordance with the EPA (2020) *Consultants Reporting on Contaminated Land: Contaminated Land Guidelines.* It documents the investigation works, with discussion of the findings in regards to human health, the environment and the aesthetic condition of the land. It concludes with statements concerning the potential for contamination to exist on the land and the site's suitability for future proposed land use.



## 2. Site Description

## 2.1 Property Identification, Location, and Physical Setting

The site identification details and associated information are presented in **Table 2-1**, while site locality and layout plans are shown in **Appendix A**, **Figures 1** and **2**. Refer also the survey plans attached in **Appendix B**.

### 2.3 Regional Setting

The topography, (hydro)geology and soil landscape information is summarised in Table 2-3.

### 2.4 Groundwater Bore Records and Local Groundwater Use

An online search for groundwater bores registered with WaterNSW was conducted by EI on 23 June 2020 (Ref. <u>https://realtimedata.waternsw.com.au/water.stm</u>). The search revealed no registered bores within a 500m radius of the site (**Appendix C**). This indicated that the local groundwater resource was not being (heavily) utilised.

A review of El's project database indicated that groundwater depths ranged from 1.7m to 2.3m below ground level (BGL) at a property approximately 150m cross-gradient from the site.

### 2.5 Site Walkover Inspection

Observations were recorded during a site walkover inspection conducted on 11 June 2020. These are summarised below. Photographs taken during the inspection are presented in **Appendix D**.

- The site was located within a mixed commercial and residential area. Railway tracks were located approximately 30m northwest to southwest of the site.
- The site displayed a slight downslope towards the northwest.
- The site was comprised of vegetation at 22 Queen Street (Lot X in DP 409704), a commercial (storage) building at 24 Queen Street (Lot 15 in DP 14782) and a commercial (factory outlet / parking) complex at 32 Queen Street (Lot 1 in DP 1154928).
- Two parallel concrete driveways were situated between the two buildings, providing access to the site from Queen Street.
- The commercial (storage) building at 24 Queen Street was a single-storey, brick structure, with tile and metal roofing (**Photographs 1** and **2**). It was used as a storage facility. Unbuilt parts of this property were covered by vegetation (northern corner) and concrete pavement (southern portion). The concrete paving was generally in good condition, with only minor cracks.
  - Fragments of fibre cement sheeting (FCS), potentially asbestos-containing materials (ACM), were observed in front of the building (i.e. in the northern site corner).
  - Building wastes were stockpiled in the southern part of this property (Photograph 3).
- The factory outlet at 32 Queen Street was a four-storey, commercial building with parking spaces. The property was mostly sealed with concrete pavement (Photographs 4 and 5), with accessible soils limited to the garden beds in front of the building.
  - Building wastes were noted at the rear (south eastern) portion of this property.
- A range of plants, including small to large, mature trees, shrubs, grasses and weeds, was observed across the non-built / paved parts of the site, none of which appeared to be distressed. The diversity and health of the vegetation suggested that phytotoxicity of local soils was not a concern.
- No visible or olfactory sign of contamination was detected during the inspection.
- No visible evidence of an underground petroleum storage system (UPSS), or an underground storage tank (UST), was observed on the site. No above-ground storage tank (AST) was present.
- The surrounding land consisted of mixed residential (approximately 150m east) and commercial properties (from northeast to southwest). Commercial activities were mainly associated with warehousing and retail activities.
- There was no NSW Fire and Rescue Station (or Training College) in the vicinity (<100m) of the site.



## 3. Site History and Searches

### 3.1 Previous Investigations

El was unaware of any previous environmental investigation being completed for the site.

### 3.2 Lotsearch Report

An environmental risk and planning report for the site was received from Lotsearch Pty Ltd during this PSI. This report, Lotsearch Reference LS012789 EL (dated 10 June 2020), is presented in full in **Appendix E**. It included historical business directories (covering the period 1950-1991), as well as searches of various environmental resources and plans archived by statutory authorities. A summary of the relevant (historical) information follows.

#### 3.2.1 Historical Business Directories

Based on the registered business directory records (covering the period between 1950 and 1991), the site was occupied by a variety of light industrial / commercial businesses, including joinery manufacture, motor towing services, motor garages and/or service stations (32 Queen Street; 1979-1991), motor dealers, contractors, glass merchants and a bowling centre.

Properties within 50m of the site were used for a range of light commercial purposes, including motels, motor towing services, tyre dealers, motor dealers, motor garages and/or service stations (1979-1990), motor panel beaters and/or spray painters.

#### 3.2.2 Other Findings

Additional findings from searches of other environmental resources and plans recorded in Lotsearch Report LS012789 EL were as follows (**Appendix E**):

- There was no recognised contaminated land within a 250m radius of the site (by way of notified / regulated sites and/or issues).
- No former gasworks or waste management facilities were present within a 250m radius of the site. One site (31 Queen Street, Coles Express Campbelltown; approximately 247m southwest of the site) was identified as a national liquid fuel facility.
- No properties that were part of the Department of Defence or EPA per- and poly- fluoroalkyl substance (PFAS) investigation / management programs were present around the site.
- There were no major AST areas or points within a 1km radius of the site.
- The site and its surroundings were not recorded as having a "naturally occurring asbestos potential".
- With respect to ASS, the site and its surroundings were classified as having "extremely low probability of occurrence" (consistent with the information in **Section 2**, **Table 2-3**).
- No mining subsidence district was present within the surveyed area.
- No state significant precincts present within a 1km radius of the site.
- No natural (e.g. bush fire) hazard applied to the site.

1994	No significant changes were observed within the site.
	The surrounding areas appeared to be relatively unchanged, with the exception of the addition of a commercial / industrial building adjacent to the south-western site boundary and the construction of a building north-west of the site.
2002	The site and surrounding areas appeared relatively unchanged, with the exception of industrial expansion north of the site, beyond the existing railway corridor.
2009	The building in the central portion of the site had been removed and construction of the main (currently existing) commercial building was in progress. The vast majority of the vegetation had been replaced with hardstand concrete. Surrounding areas were moderately modified, with commercial buildings upgraded and/or replaced, while the amount of vegetation was reduced.
2019	The site layout was consistent with the current plan. A large commercial building was within the central portion of the site, covering a significant portion of 32 Queen Street. Surrounding areas were relatively unchanged.



### 3.4 Council Information

An application to access archived files relating to the site was submitted to Campbelltown City Council as part of this PSI. Response from Council was still pending at the time of report writing. Should pertinent information be identified upon receipt of council records, this PSI report will be updated accordingly.

### 3.5 SafeWork NSW Dangerous Goods Register Records

A site search request was submitted to SafeWork NSW during this PSI, as a means to gain information relating to the storage of hazardous chemicals (dangerous goods).

SafeWork NSW identified an underground tank at property 32 Queen Street, located next to the western boundary of the site (**Figure 2**). The provided records are summarised in **Table 3-2** below and presented in **Appendix F**. According to the documents, the Peter Warren Group (licence holder) vacated the site around 2005 and all fuel was pumped from the tanks. This was supported by a declaration provided by the licence holder dated July 2006.

#### 3.6 EPA Online Records

Searches of public registers maintained by the EPA for statutory notices and licensing agreements issued under the *Contaminated Land Management Act 1997* and *Protection of the Environment Operations Act 1997* were conducted by EI for this PSI.

#### 3.6.1 Record of Notices Under Section 58 of CLM Act 1997

An on-line search of the contaminated land public record was conducted on 25 June 2020. The contaminated land public record is a searchable database of:

- Orders made under Part 3 of the CLM Act 1997;
- Notices available to the public under Section 58 of the CLM Act 1997;
- Approved voluntary management proposals under the CLM Act 1997 that have not been fully carried out and where the approval of the EPA has not been revoked;
- Site audit statements provided to the EPA under Section 53B of the CLM Act 1997 that relate to significantly contaminated land;
- Where practicable, copies of anything formerly required to be part of the public record; and
- Actions taken by the EPA under Section 35 or 36 of the *Environmentally Hazardous Chemicals Act 1985* (the EHC Act 1985).

The search confirmed that the site and surrounding lands within close proximity (≤250m) were not subject to any regulatory notices relevant to the above legislations.



#### 3.6.2 List of NSW Contaminated Sites Notified to EPA

A search through the *List of NSW Contaminated Sites Notified to the EPA* under Section 60 of the CLM Act 1997 was conducted on 25 June 2020. This list is maintained by the EPA and includes properties on which contamination has been identified, but not deemed to be impacted significantly enough to warrant regulation. The site and surrounding lands within close proximity (≤250m) had not been notified as contaminated to the EPA (i.e. were not included in the list).

#### 3.6.3 POEO Public Register

A search of the *Protection of the Environment Operations Act 1997* public register was conducted on 25 June 2020. This public register contains records related to environmental protection licences, applications, notices, audits, pollution studies and reduction programs. The search confirmed that the site and surrounding lands within close proximity (≤250m) were not subject to any licensing agreements / notices / programs etc. relevant to this legislation.

**Note:** Lotsearch Report LS012789 EL recorded two organisations, identified as Australian Rail Track Corporations Limited (27m west) and Sydney Trains (27m west), were operating "railway systems activities" under the *POEO Act 1997* (**Appendix E**).



## 4. Site Characterisation

### 4.1 Rationale

The primary purpose of this PSI was to appraise the potential for contamination to exist on the site. If it was deemed that there was such potential, the environmental and human-health risks associated with contamination were to be evaluated. These risks were defined as the probability that the utility of the site would be diminished by the presence of soil, soil vapour and/or groundwater contamination.

This appraisal did not involve intrusive sampling and laboratory analysis of soils, soil vapours or groundwater. Instead, the potential for contamination was based on a desktop study, collating information from history searches and government-maintained databases, as well as a walkover inspection. Professional judgement was then applied, based on previous experience.

### 4.2 Summary of Site History

The site was used for low density, residential and open space purposes up to 1965 (at least). Redevelopment of the site, which included the replacement of residences and vegetation with commercial buildings and hardstand concrete, commenced sometime between 1965 and 1975. The storage building at 24 Queen Street was likely constructed between 1975 and 1984, while the factory outlet / parking complex at 32 Queen Street was constructed around 2009. Hence, the layout was finally consistent with the current plan sometime between 2009 and 2019. The commercial activities which took place on the site included joinery manufacture, motor towing services, motor garages and/or service stations (32 Queen Street; 1979-1991), motor dealers, contractors, glass merchants and a bowling centre.

#### 4.3 Subsurface Conditions

Based on the map information and site walkover inspection (**Section 2**), as well as data from previous investigations undertaken by EI for properties within close proximity of the site, the local sub-surface conditions were expected to be:

- A thin layer of fill, overlying natural silty clays (and weathered shale bedrock); with
- Shallow groundwater levels (possibly <3m BGL), the inferred hydraulic gradient being north-westerly, towards Bow Bowing Creek.

The potential for ASS to be present on the site was extremely low.

#### 4.4 Potential Contamination Sources

The potential contamination sources were as follows:

- Former commercial activities (joinery manufacture, motor towing services, motor garages and/or service stations (32 Queen Street; 1979-1991), motor dealers, contractors, glass merchants and a bowling centre);
- Imported fill materials of unknown origin and quality (used to grade the site);
- Hazardous building materials (including ACM and lead-based paints), present within the fabrics of the former / existing structures;
- The application of pesticides around building (footing) perimeters;
- Leaks from vehicles in the parking areas; and
- Off-site migration from neighbouring commercial properties.

### 4.4.1 PFAS Assessment

EPA (2017) requires that PFAS are considered when assessing land contamination. A desktop survey of PFAS occurrence is provided in **Table 4-1**. This survey was based on guidelines from the *PFAS National Environmental Management Plan* (NEMP, 2020), from which a decision could be made as to whether PFAS sampling of soil and groundwater was required.

In this instance, the potential for PFAS to be present on-site was low and subsequently PFAS sampling / analysis of soil and water was unwarranted.

### 4.4.2 Emerging Chemicals

The EPA uses Chemical Control Orders (CCOs) as a primary legislative tool under the EHC Act 1985, to control chemicals of concern and limit their potential impact on the environment. Considerations for chemicals controlled by CCOs, and other potential emerging chemicals, are outlined in **Table 4-2**.

In this instance, the potential for an emerging chemical of concern to be present on-site was low, with the possible exceptions of polychlorinated biphenyls (PCB) and pesticides in imported filling.

## 4.5 Potential Contaminants

The contaminants of potential concern (COPC) at the site were considered to be:

- Priority Metals (PM) arsenic, cadmium, chromium, copper, lead, mercury, nickel, zinc;
- Total Recoverable Hydrocarbons (TRH);
- Volatile Organic Compounds (VOC); including
- Benzene, Toluene, Ethylbenzene and Xylenes (BTEX);
- Polycyclic Aromatic Hydrocarbons (PAH);
- Organochlorine and Organophospate Pesticides (OCP / OPP);
- Polychlorinated Biphenyls (PCB);
- Phenols; and
- Asbestos.

## 4.6 Potential Contamination in the Context of the Site

An assessment of the potential contamination risks for the site is outlined in **Table 4-3**.

Overall, the potential for site contamination derived from the identified sources was considered to range from low to moderate, except in relation to the hazardous building products, which was considered to pose a high likelihood.

The presence of impervious clay soils underlying the site would generally inhibit migration of any (mobile) contaminants to the underlying aquifer. However, former UPSSs on 32 Queen Street, used as part of the service station activity (1979-1991), represent a preferred, or more accessible, vertical pathway for petroleum hydrocarbons, given that the tanks would have been close to, if not within, the groundwater table (<3m BGL). Potential migration of contaminants from off-site sources, such as the former service stations located to the southwest and west, was considered less relevant, being cross- to down- gradient of the site.

#### 4.7 Potential Receptors

The following potential receptors of contamination from the site were identified:

- On-site construction / demolition workers (during future redevelopment);
- Users of the adjacent land during the construction works;
- Future site users; and
- The local groundwater resource.



### 4.8 Conceptual Site Model

In accordance with NEPC (2013) *Schedule B2 - Guideline on Site Characterisation*, El developed a conceptual site model (CSM) that assessed plausible linkages between potential contamination sources, migration pathways and human and environmental receptors (**Table 4-4**). The CSM provides a framework for identifying gaps in the existing site characterisation.

#### 4.9 Data Gaps

Based on the presented CSM, there was potential for contamination to exist on the land. It was considered that intrusive investigations were required following demolition and prior to any future redevelopment, to further characterise the site soils and groundwater, and determine the suitability of the land for future proposed use.

Note that the requested Council record search had not been completed by the time of report writing. This search represents an additional data gap.

## 5. Conclusion

The property identified as 22-32 Queen Street, Campbelltown NSW was the subject of a Preliminary Site Investigation, the main objective being to appraise the potential for site contamination.

The key findings of this PSI were as follows:

- The site (20,465.7m<sup>2</sup>) was comprised of vegetation at 22 Queen Street, one brick storage building at 24 Queen Street and one commercial (factory outlet / parking) complex at 32 Queen Street.
- The site was mostly sealed with buildings and hardstand (concrete) pavements. The remaining (unbuilt) parts were vegetated areas.
- Waste building materials were stockpiled in the south (eastern) parts of the site (at the rears
  of the two buildings). Fragments of FCS were observed on the ground surface in front of
  the building on 24 Queen Street (i.e. in northern site corner).
- The site was used for low density, residential and open space purposes up to 1965 (at least). Redevelopment of the site, which included the replacement of residences and vegetation with commercial / industrial buildings and hardstand concrete, commenced sometime between 1965 and 1975. The storage building at 24 Queen Street was likely constructed between 1975 and 1984, while the factory outlet / parking complex at 32 Queen Street was constructed around 2009.
- The commercial activities which took place on the site included joinery manufacture, motor towing services, motor garages and/or service stations (32 Queen Street; 1979-1991), motor dealers, contractors, glass merchants and a bowling centre.
- No visual or olfactory evidence of (gross) contamination was detected on the site.
- During the site walkover, there was no visual evidence that a UST or AST was present on the site. However, the SafeWork NSW search indicated that UPSS was present at 32 Queen Street as a result of former service station activity between 1979 and 1991.
- The site was free of statutory notices and licensing agreements issued under the *Contaminated Land Management Act 1997* and *Protection of the Environment Operations Act 1997.* The site was not included on the *List of NSW Contaminated Sites Notified to the EPA.*
- There were no registered bores within a 500m radius of the site, indicating that the local groundwater resource was not being (heavily) utilised.
- Potential (off-site) migration of contaminants from neighbouring properties was considered to be low, given that the most likely sources were cross- to down- gradient of the site.
- The CSM established there was low to moderate potential for site contamination derived from the identified sources, except in relation to the hazardous building products, which was considered to pose a high likelihood.

Based on the findings of this PSI and with due consideration of EI's Statement of Limitations (**Section 7**), it was concluded there was potential for contamination to exist on the site. Following demolition and prior to any future redevelopment, a detailed (Phase 2) investigation should be undertaken, to further characterise the soils and groundwater at the site and determine the suitability of the land for future proposed use.



## 6. Recommendations

El provide the following recommendations in relation to any future development of the property:

- Before commencement of any demolition works, a Hazardous Materials Survey (HMS) should be completed by a suitably qualified consultant, to identify any hazardous materials present within the existing building fabrics.
  - If present, all identified hazardous materials must be appropriately managed, to maintain worker health and safety during demolition works and prevent the spread of hazardous substances.
  - An asbestos clearance inspection and certificate should be completed by a suitably qualified professional (SafeWork NSW Licensed Asbestos Assessor) following the removal of all ACM from the site.
  - Where clearance inspection indicates the presence of hazardous materials remaining on the site, further removal and validation works must be undertaken.
    - El note that a HMS has been completed in conjunction with the current PSI.
- Following demolition and prior to any future redevelopment, a detailed site investigation (DSI) should be undertaken, to further characterise the contamination status of soils and groundwater.
  - Intrusive investigation is form part of the DSI. This should include soil and groundwater sampling, with associated laboratory analyses for the identified COPC (Section 4.5). In designing the sampling, analytical and quality plan (SAQP) for such investigation, the EPA (1995) Sampling Design Guidelines should be referred to. This should include a Ground Penetrating Radar (GPR) survey of site surfaces to identify and locate any UST/UPSS remaining onsite.
- Soil materials to be removed from site as part of any excavation and foundation works (including virgin excavated natural material (VENM)) are to be classified prior to off-site disposal in accordance the EPA (2014) Waste Classification Guidelines.
- Any material being imported to the site should be validated as suitable for the intended use in accordance with EPA guidelines.
