#### **MATTER DETERMINED**

PPSHCC-134 – Newcastle – DA2022/00572 at 141 Minmi Road, Wallsend 2287 – Organics Processing Facility - Summerhill Waste Management Centre (as described in Schedule 1)

#### PANEL CONSIDERATION AND DECISION

The Panel considered the matters listed at item 6, the material listed at item 7 and the material presented at briefings and meetings and the matters observed at the site inspection listed at item 8 in Schedule 1.

Following a public determination in June 2024 the Panel deferred the determination of this application to seek further information and clarification of the following matters:

- (i) A review of the NorthStar peer review by the applicant's odour consultant that includes specific answers to the issues raised.
- (ii) An explanation of the interrelationship of the odour conditions applying to the subdivision approval under DA 2087/2018/REV.
- (iii) Clarification of whether a concrete batching plant is or is not included in the application, for how long, and an assessment of the traffic and noise impacts arising from either its inclusion or exclusion.
- (iv) Specific answers and clarification of what consultation occurred in satisfaction of the SEARs requirements prior to lodgement of the DA as outlined in the submission received from Winten.

In response to this deferral the applicant provided additional information. Council prepared a supplementary report dated 4 September 2024 for the Panel's consideration. The Panel has considered this report and Council's previous report.

The Panel is satisfied that the Organic Processing Facility will not result in unreasonable impacts on adjoining sensitive land uses because of the enclosed nature of the facility, the measures proposed to treat odour (biofilter systems) and separation distances.

The Panel considers that the application has merit and warrants approval.

#### **Development application**

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

#### **REASONS FOR THE DECISION**

The Panel determined to approve the application for the following reasons:

- 1. The facility will remove organic waste that would otherwise be destined for landfill
- 2. The impacts of the development can be managed and mitigated on a site suitable for the proposed use
- 3. The development is consistent with the statutory and policy framework applying to the site.

### **CONDITIONS**

The development application was approved subject to the conditions in the council assessment report

## **CONSIDERATION OF COMMUNITY VIEWS**

In coming to its decision, the Panel considered written submissions made during public exhibition and heard from all those wishing to address the Panel. The Panel notes that issues of concern included:

- Adequacy of notification
- Air, noise and traffic impacts
- Greenhouse gas assessment
- Stormwater
- Council related DA processes.

The Panel considers that concerns raised by the community have been adequately addressed in the assessment and supplementary reports.
