Introduction

- Council is yet to undertake its full application assessment, so this record is not a final list of the issues they will need to consider in order to draft their recommendation.
- The application is yet to be considered by the Hunter & Central Coast Regional Planning Panel and therefore future comment will not be limited to the detail contained within.

Council summary

- o Airport operations are undertaken by Council
- Outline of proposal provided as the demolition/reconfiguration of the existing Short Stay 1 Car Park, including new through road, installation of shade structures and landscaping

- Site Masterplan approved in 2014, with a number of other approvals also granted for the site (including terminal and carpark extensions), with inter-relationship to be understood
- Proposal conflicts with Masterplan approval in relation to car parking, with Council requesting amendment to Masterplan approval
- Development site forms part of the Special Activation Precinct, with draft identifying the site as 'airport' and no subsequent issues for proposal
- Pedestrian connectivity to be clarified northern loop road/pedestrian link to the taxi stand
- o Additional information to be requested in regard to:
 - Construction Management Plan outlining airport operations during construction
 - Traffic Management Plan including the staging/delivery of car parking

Applicant introduction of proposal

- Overview of existing projects to support international travel
- o Commercial agreements with operators include infrastructure requirements
- Site is zoned SP2 Infrastructure (Defence/Air Transport Facility) proposal is permissible in the zone
- o Supporting specialist reports and investigations provided with application
- Consent history
 - 2014 Alterations and Additions to Terminal 6 stages (Stage 1 completed)
 - 2021 Extension to existing car parks
- o Identified issues -
 - Consistency with existing Terminal Expansion consent removal of sewerage infrastructure by Department of Defence yet to occur and timing is unknown (estimated 5-10 years)
 - Current proposal is an alternative scheme to support terminal expansion
 - Modification to Consent to Terminal Expansion is being prepared to remove inconsistency
 - Extension of short and long stay car park facilities to be constructed prior to construction commencing on proposal
 - Additional 1,080 car parking spaces proposed to offset proposed net reduction in parking

- Application should include identification of inconsistencies with previous approvals arising from this matter and deal with them through this proposal (s4.17(1)(b))
- Assessment report to outline any inconsistencies between the proposed development and current approvals
- Timing of works (car parking)
- o Comprehensive and timely response to RFI requested

- Traffic management and pedestrian safety
- Car parking staging
- Continuation of airport operations during construction
- Consistency with other recent approvals
