#### **MATTER DETERMINED**

PPSHCC-259 – Singleton – DA 8.2023.455.1 - 147 Gardner Circuit, Singleton Heights 2330 – Proposed Group Home and Community Facility (as described in Schedule 1)

# PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel has had the benefit of several briefings from Council and the applicant. On the 7<sup>th</sup> of May 2024 the Panel held a public meeting to hear from those who had made a submission and inspected the site.

The applicant provided further information, including a Social Impact Assessment which has been considered by the Panel. The Panel has considered the assessment report, and the matters raised in the submissions.

The proposal is for a residential use within an existing residential area. The provision of facilities like these in an existing community is important to the health and wellbeing of the future occupants. The proposed development will provide a social and public benefit to the broader community.

The potential impacts arising from the development can be managed and mitigated. The proposal has merit and could be approved.

# **Development application**

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

#### **REASONS FOR THE DECISION**

The Panel determined to approve the application for the reasons outlined in the council report and for the following reasons:

- i. The proposed development has been designed to the site conditions and the impacts arising from the development can be mitigated.
- ii. The proposed development will meet an urgent need for these types of facilities in the broader area.
- iii. The built form response is compatible with the surrounding streetscape and context.

# **CONDITIONS**

The development application was approved subject to the conditions in the council assessment report.

# **CONSIDERATION OF COMMUNITY VIEWS**

In coming to its decision, the Panel considered written submissions made during public exhibition and heard from all those wishing to address the panel. The Panel notes that issues of concern included:

- Concerns surrounding the exhibition process
- Traffic and access
- Social and economic impacts
- Planning and environmental impacts including permissibility, streetscape, noise and lighting
- Potential for crime

The Panel considers that concerns raised by the community have been adequately addressed in the assessment report and that no new issues requiring assessment were raised during the public meeting.
