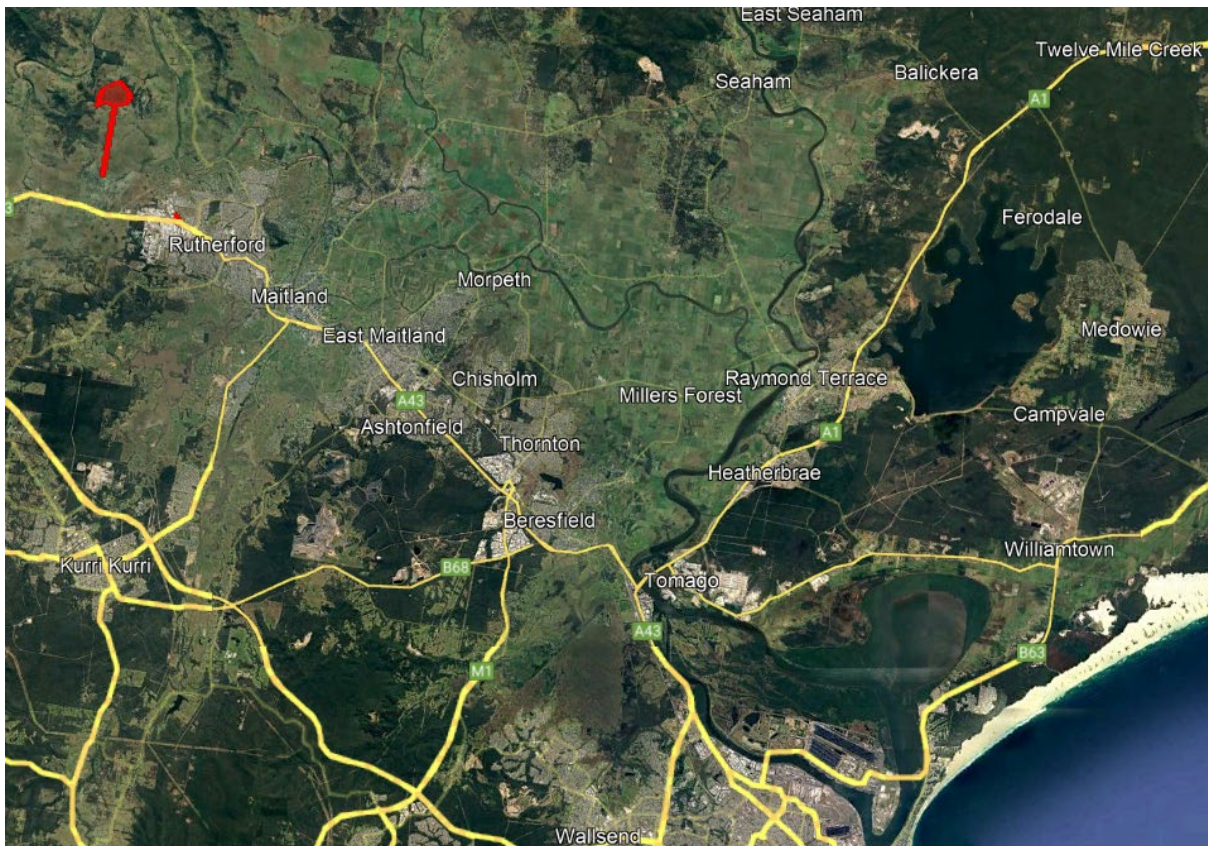


Figure 1. Region of Project Area

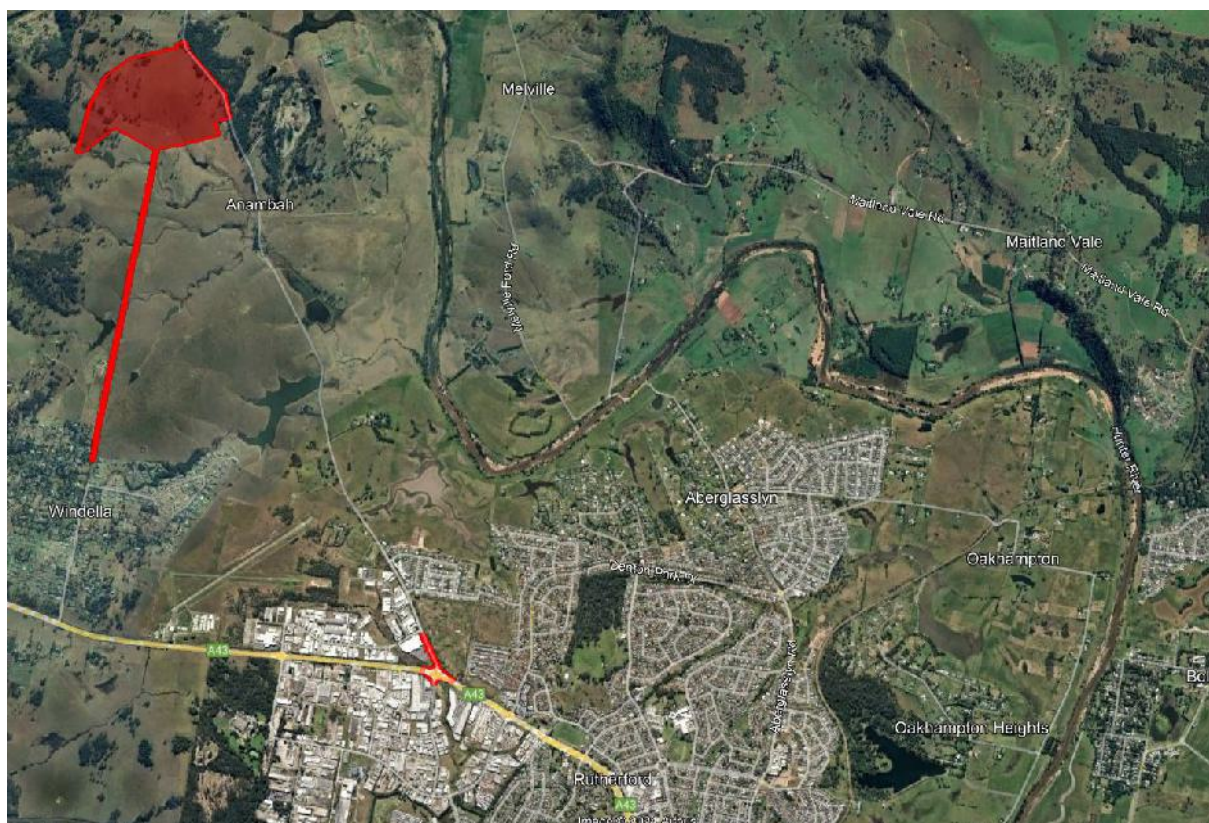


Figure 2. Location of Project Area

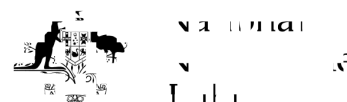

The purpose of this letter is to assist you as the proposed applicant in undertaking Aboriginal community consultation in accordance with the relevant legislation and guidelines.

The consultation process involves getting the views of, and information from, Aboriginal people and reporting on these. It is not to be confused with other field assessment processes involved in preparing a proposal and an application. Consultation does not include the employment of Aboriginal people to assist in field assessment and/or site monitoring. Aboriginal people may provide services to proponents through a contractual arrangement however, this is separate from consultation. The proponent is not obliged to employ those Aboriginal people registered for consultation. Consultation as per these requirements will continue irrespective of potential or actual employment opportunities for Aboriginal people.

In accordance with Clause 60 (10) of the National Parks and Wildlife Regulation 2019, where an agreement of the kind listed below specifies or identifies a modified or alternative consultation process for the purposes of Part 6 of the National Parks and Wildlife Act 1974, the applicant is to undertake consultation in accordance with the modified or alternative process. The applicable agreements are:

- a) a registered Indigenous Land Use Agreement under the Native Title Act 1993 of the Commonwealth entered into between an Aboriginal community and the State,
- b) a lease entered into under Part 4A of the Act,
- c) an agreement entered into by the Secretary and a board of management reserved under Part 4A of the Act that has the consent of Aboriginal owner board members for the land concerned,
- d) an agreement entered into between an Aboriginal community and the Department of Planning, Industry and the Environment.

Where you believe your application is wholly or partially located within an area subject to any of the above agreements, please provide further correspondence (including mapping, if required) detailing the applicable agreement and its relationship to the application area to heritagemailbox@environment.nsw.gov.au. Heritage NSW will respond with further advice.

Where the above does not apply, please proceed with consultation in accordance with the Clause 60 (1-9) of the National Parks and Wildlife Regulation 2019 and Aboriginal Cultural Heritage Consultation Requirements for Proponents 2010 (the "Consultation Requirements"). A copy of the Consultation Requirements can be found on the OEH website at: <http://www.environment.nsw.gov.au/resources/cultureheritage/commconsultation/09781ACHconsultreq.pdf>.

Under the Consultation Requirements, a proponent is required to provide Aboriginal people who may hold cultural knowledge relevant to determining the cultural significance of Aboriginal objects and/or places as relevant to the proposed project area, with an opportunity to be involved in consultation. Section 3.3.1 of the Consultation Requirements states that Aboriginal people who can provide this information are, based on Aboriginal lore and custom, the traditional owners or custodians of the land that is the subject of the proposed project.

The Consultation Requirements also state that:

Traditional owners or custodians with appropriate cultural heritage knowledge to inform decision making who seek to register their interest as an Aboriginal party are those people who:

- continue to maintain a deep respect for their ancestral belief system, traditional lore and custom

- recognise their responsibilities and obligations to protect and conserve their culture and heritage and care for their traditional lands or Country
- have the trust of their community, knowledge and understanding of their culture, and permission to speak about it.

This list is provided to proponents in accordance with Clause 60(2)(a)(i) of the National Parks and Wildlife Regulation 2019 and section 4.1.2 of the Aboriginal Cultural Heritage Consultation Requirements for Proponents 2010.

The stakeholders identified on this list may have an interest in the proposed project area and may hold knowledge relevant to determining the cultural significance of Aboriginal objects and/or places.

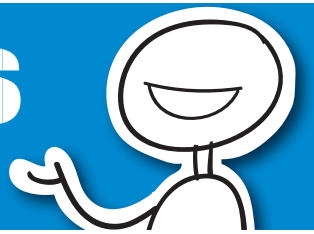

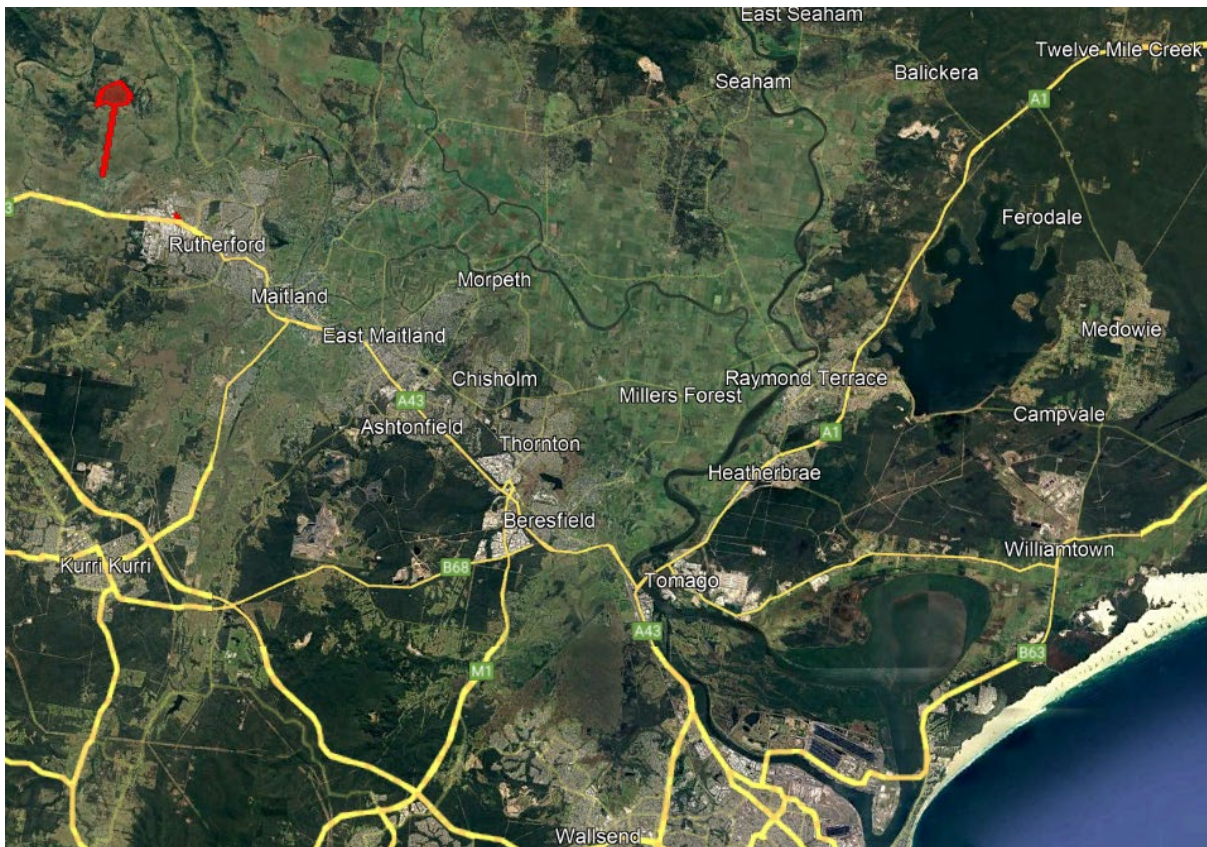


Figure 1. Region of Project Area

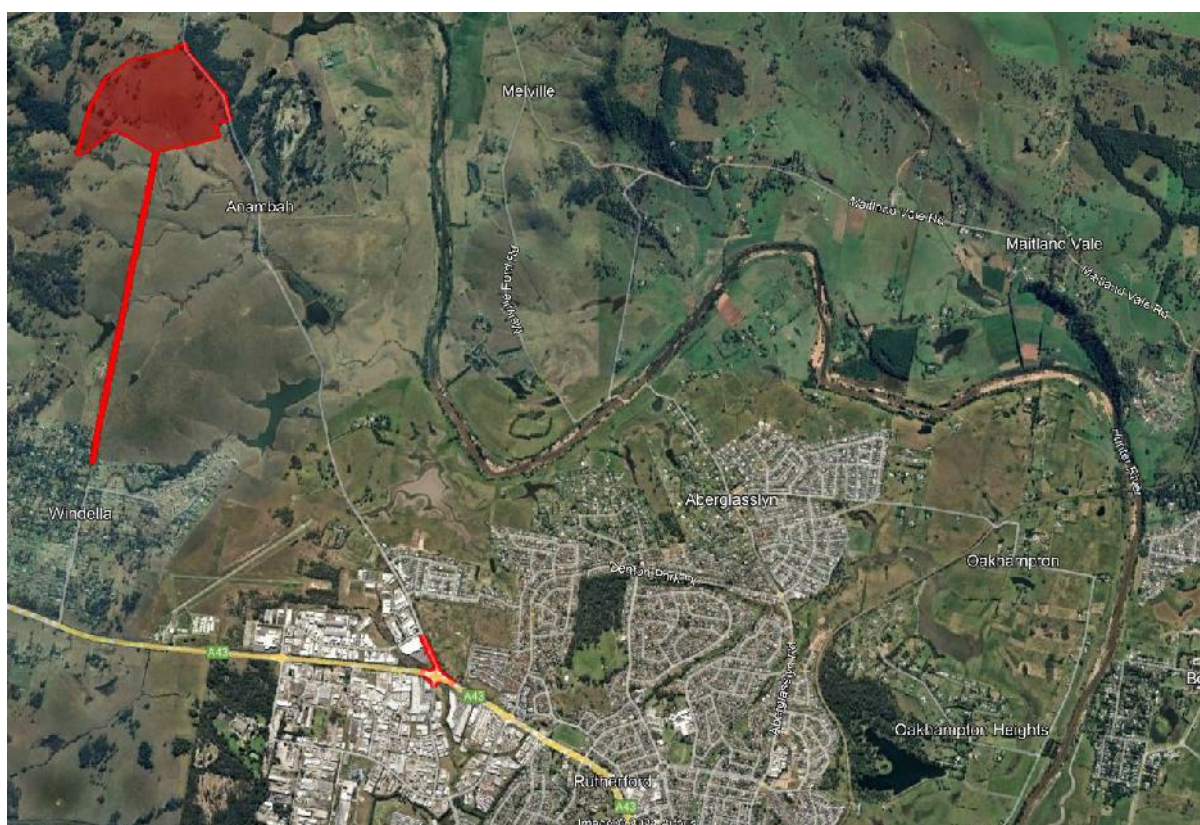


Figure 2. Location of Project Area

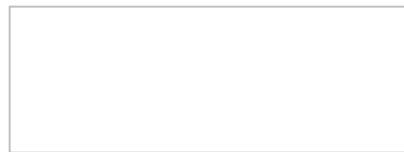

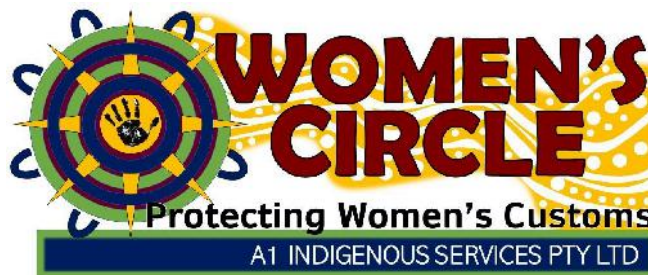

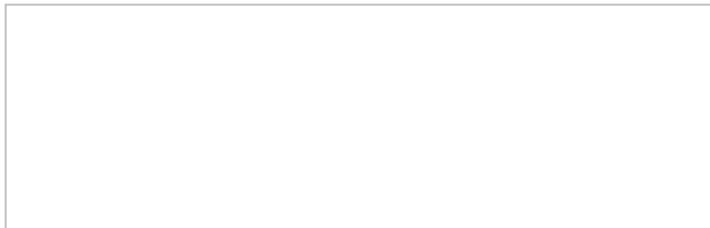

The purpose of this letter is to present information about the project and provide a proposed assessment methodology to Registered Aboriginal Parties (RAPs) for review and comment.

Project Information

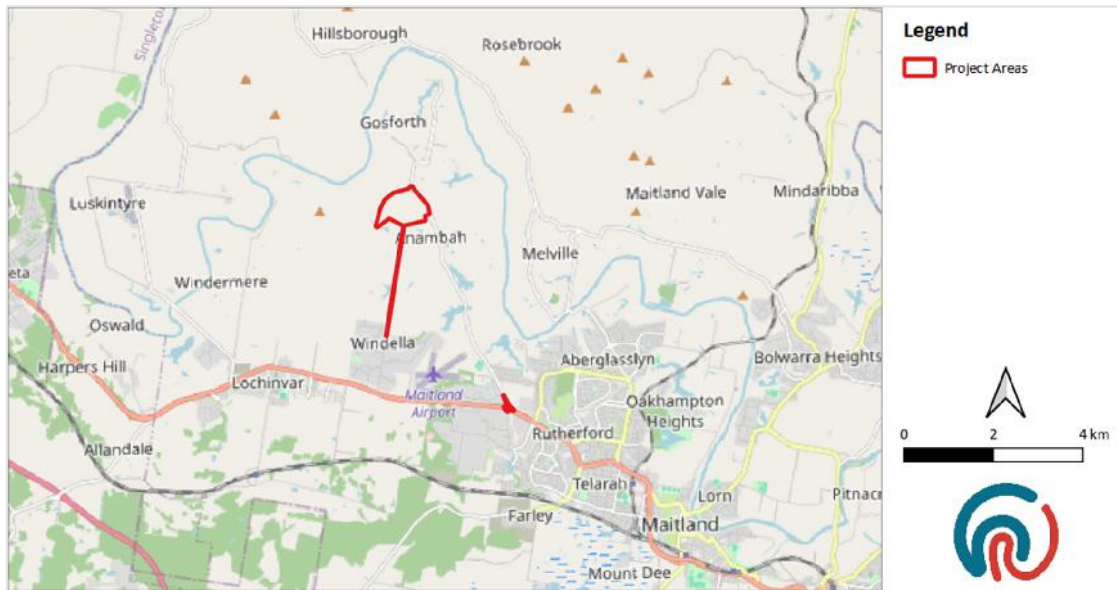


Figure 1. Region of Project Area

Heritage Now has been engaged by the Thirdi Anambah Pty Ltd (the Proponent: Thirdi Anambah Pty Ltd, 53 Hume Street, Crows Nest NSW 2065) to undertake an ACHA report addressing a proposed residential development at 559 Anambah Road, Gosforth (Figure 1). There are three broad elements to the works which include:

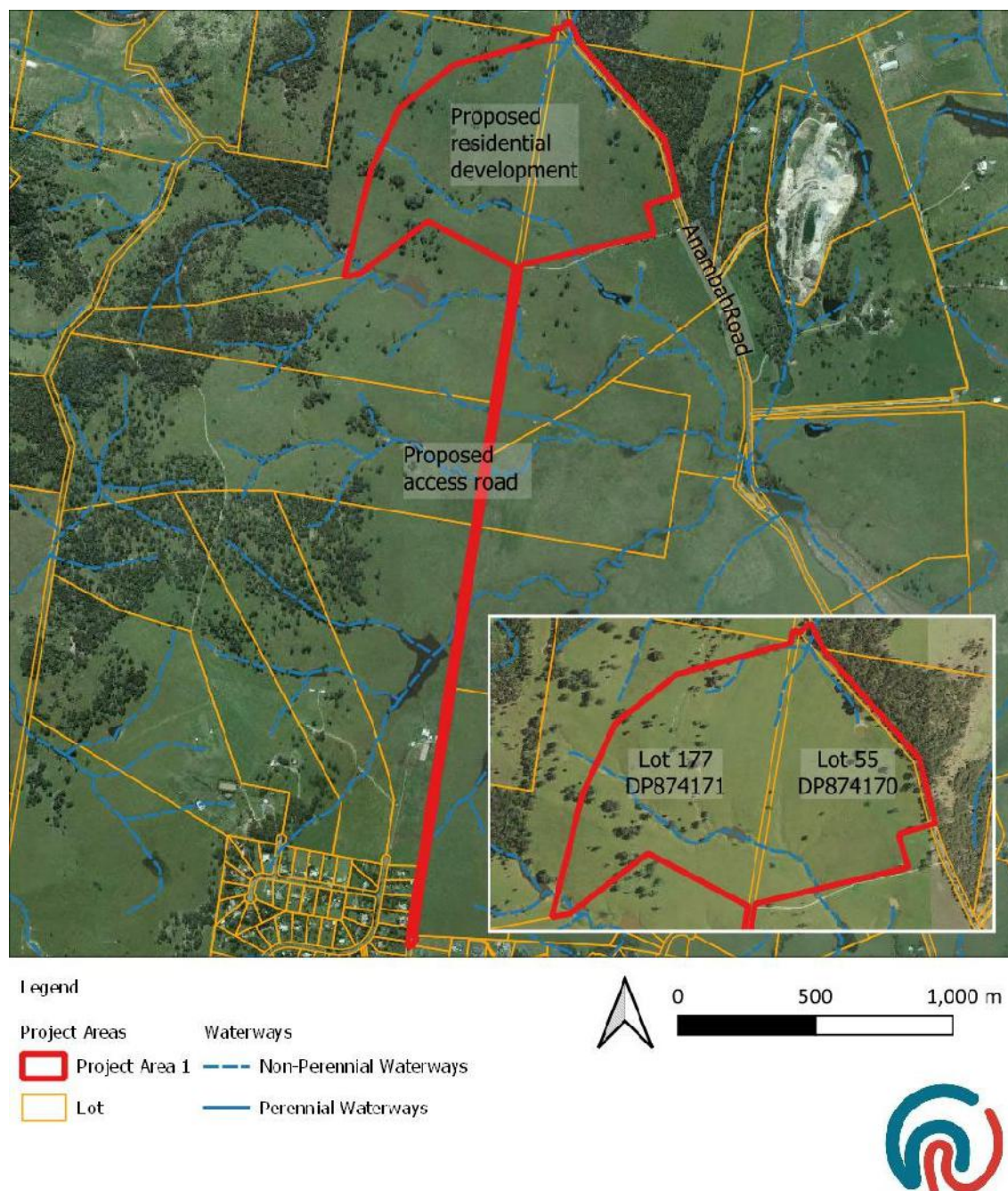


Figure 2. Location of proposed residential development and access road

- A residential development encompassing c.69.6ha including construction of housing, open spaces, landscaping, service installation and residential roads (Figure 2)
- A new access road connecting River Road, Windella, to the planned new residential development (c.2.5km in length; Figure 2)
- Upgrade works to the existing Anambah Road/New England Highway (A43)/Shipley Drive interchange (Figure 3).

The Proponent is in the process of seeking approval of a development application for a Concept Masterplan of this Project and requires an Aboriginal Cultural Heritage Assessment.

Methodology

The ACHA report will be prepared in accordance with the *NSW National Parks and Wildlife Act 1974* and the *NSW National Parks and Wildlife Regulation 2019*, as well as the relevant guidelines including, but not limited to, the:

- *Guide to Investigating, Assessing and Reporting on Aboriginal Cultural Heritage in NSW*
- *Code of Practice for Archaeological Investigation of Aboriginal Objects in NSW*
- *Due Diligence Code of Practice for the Protection of Aboriginal Objects in NSW*
- *Guide to Aboriginal Heritage Impact Processes and Decision-Making*
- *Aboriginal Cultural Heritage Consultation Requirements*

Archaeological Background

The landscape within and adjacent to the Project Area is that of undulating hills overlying a basalt, siltstone and sandstone geology. Numerous 1st and 2nd order creeks flow through the area, ultimately draining into the Hunter River which flows around the Project Area to the north-west, north and east at a distance of 800m-2km (Figure 1).

There are 20 Aboriginal heritage sites within 300m of the Project Area, comprising stone artefacts and/or Potential Archaeological Deposits (PADs). Within the Project Area itself, three artefact sites and areas of PAD were identified during a December 2023 survey of the residential development area, as part an Aboriginal Heritage Due Diligence Assessment for the Project.

All of the above-mentioned Aboriginal heritage sites are positioned on flat or gently sloping topography within 100m of a water source. The generally small number of artefacts present at each site appear to be representative of small, short term/transitory camp sites. More permanent camp sites are predicted closer more reliable sources of fresh water, i.e. the Hunter River and its more significant tributaries.

Proposed Assessment Methodology

The ACHA report will be prepared in accordance with the following guidelines:

- *Guide to investigating, assessing and reporting on Aboriginal cultural heritage in NSW* (Office of Environment and Heritage 2011)
- *Code of practice for archaeological investigation of Aboriginal objects in New South Wales* (Department of Environment, Climate Change and Water 2010)
- *Aboriginal cultural heritage consultation requirements for proponents 2010* (Department of Environment, Climate Change and Water 2010)

The report will include the following:

- a description of the Aboriginal objects located within the area of the proposed activity;
- a description of the cultural heritage values, including the significance of the Aboriginal objects and declared Aboriginal places, that exist across the whole area that will be affected by the proposed activity and the significance of these values for the Aboriginal people who have a cultural association with the land;
- description of the survey work undertaken for the ACHA and its findings;

- documentation of Aboriginal consultation in accordance with Section 60 of the National Parks and Wildlife Regulation 2019;
- documentation of the views of those Aboriginal people regarding the likely impact of the proposed activity on their cultural heritage;
- documentation of actual or likely harm posed to the Aboriginal objects from the proposed activity, with reference to the cultural heritage values identified; and
- practical measures that can be taken to protect and conserve those Aboriginal objects;
- practical measures that may be taken to avoid or mitigate any actual or likely harm, alternatives to harm or, if this is not possible, to manage (minimise) harm.

Survey Methodology

A robust survey of the proposed residential area was undertaken by Heritage Now and a RAP in December 2023, and therefore will not be surveyed again as part of this ACHA. However, the area of the proposed new access road and intersection upgrade area will be subject to a comprehensive pedestrian survey, undertaken in accordance with the archaeological survey requirements of the *Code of practice for archaeological investigation of Aboriginal objects in New South Wales*. The purpose of the survey will be to record all (or a representative sample) of the material traces and evidence of Aboriginal land use, and identify where it can be inferred that potential archaeological deposits have a likelihood of being present under the ground surface.

The survey will be conducted by an archaeologist and RAP team, who will be spread out approximately 2m-10m from each other (this may vary according to ground surface conditions), undertaking either north/south or east/west transects across the entirety of these sections of the Project Area, pending on-site conditions.

Following the completion of the ACHA report, incorporating the results of the survey, a draft copy of the ACHA will be sent out for review, prior to finalisation.

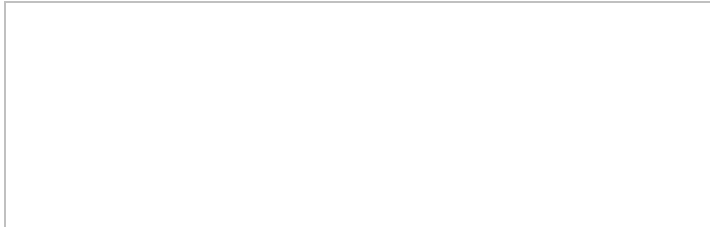

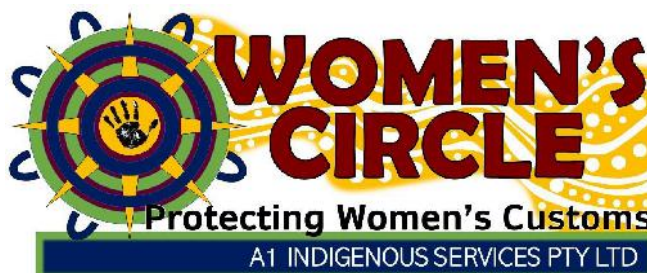

The purpose of this letter is to present information about the project, provide a proposed assessment methodology to Registered Aboriginal Parties (RAPs) for review and comment.

Project Information

Heritage Now has been engaged by the Thirdi Anambah Pty Ltd (the Proponent: Thirdi Anambah Pty Ltd, 53 Hume Street, Crows Nest NSW 2065) to undertake an ACHA report and preparation of test excavation methodology addressing a proposed residential development at 559 Anambah Road, Gosforth.

Archaeological Background

Heritage Now and Mindaribba Local Aboriginal Land Council completed archaeological survey of the Project Area in December 2023. Two surface artefact sites were identified next to the creek line running through the middle of the study area (Anambah AFT-01 and Anambah AFT-02), and this entire creek line, and the 2nd order creek in the south-west corner of the study area, were assessed as being archaeologically sensitive, with potential for subsurface archaeological material (Anambah PAD). The area of PAD will be impacted by the proposed development, therefore test excavation was recommended by Heritage Now.

Heritage NSW provided a Request for Further Information on 17 October 2024, requesting the ACHAR includes further information to support the development application, namely:

- Consultation records for Appendix 1
 - Consultation records will be compiled with the completed ACHA and Test Excavation Report, it will include log of Aboriginal consultation including emails and phone calls, as well as documentation of correspondence, copies of emails and etc.
- Archaeological survey methodology

- The ACHA will be updated to include further information on the survey methodology
- Archaeological test excavation methodology and results
 - Heritage Now will complete an excavation based on the methodology provided below. This methodology and the results will be included in the updated ACHA and Test Excavation report
- Additional mapping and figures
 - Additional maps will be inserted with the most current and up to date plans of the Project
 - Maps updated to show the AHIMS number registrations of the sites in the Project Area
 - Proposed AHIP map extent (if AHIP is required)
 - Significance assessment table
 - Impact assessment table
- Revisions required to the Aboriginal Cultural Heritage Assessment Report to comply with guidelines and legislative requirements. A copy of the response from Heritage NSW is attached.

Proposed Methodology

The amended ACHA report will be prepared in accordance with the following guidelines:

- *Guide to investigating, assessing and reporting on Aboriginal cultural heritage in NSW* (Office of Environment and Heritage 2011)
- *Code of practice for archaeological investigation of Aboriginal objects in New South Wales* (Department of Environment, Climate Change and Water 2010)
- *Aboriginal cultural heritage consultation requirements for proponents 2010* (Department of Environment, Climate Change and Water 2010)

The report will include the following:

- a description of the Aboriginal objects located within the area of the proposed activity;
- a description of the cultural heritage values, including the significance of the Aboriginal objects and declared Aboriginal places, that exist across the whole area that will be affected by the proposed activity and the significance of these values for the Aboriginal people who have a cultural association with the land;
- documentation of Aboriginal consultation in accordance with Section 60 of the National Parks and Wildlife Regulation 2019;
- documentation of the views of those Aboriginal people regarding the likely impact of the proposed activity on their cultural heritage;
- documentation of actual or likely harm posed to the Aboriginal objects from the proposed activity, with reference to the cultural heritage values identified; and
- practical measures that can be taken to protect and conserve those Aboriginal objects;
- practical measures that may be taken to avoid or mitigate any actual or likely harm, alternatives to harm or, if this is not possible, to manage (minimise) harm.

Test Excavation Methodology

An archaeological test excavation will be undertaken across the Stage 1 area only to determine whether subsurface Aboriginal objects are present within the proposed impact area and to characterise the Aboriginal objects and deposits. The current scope for the test excavation is limited to the extent of Stage 1 only because, although the ACHAR was prepared for the entire Concept Masterplan, s4.22(5) of the EP&A Act only requires the Consent Authority to consider the likely impact of the carrying out of development. In this instance the likely impact of carrying out the development for subsequent stages will be considered as part of subsequent development applications for those stages. The investigation will be carried out in accordance with the archaeological test excavation methodology provided below, and Requirement 16a of the *Code of Practice for Archaeological Investigation of Aboriginal Objects in NSW*:

- The test excavation will involve hand excavation of test pits located in 50m intervals on a systematic grid across the Anambah PADs, with adjustments to avoid placing pits directly in the creek line. The grid has been orientated to be in line with the creek, to be able to test distance from the water, and if there is any correlation between artefact density and distance from the water.
- If a significant amount of archaeological material is uncovered during testing, additional pits may be placed within the grid, in consultation with Aboriginal stakeholders
- The test excavation will be conducted in multiple stages, with the test pits within the Stage 1 earthworks to be excavated and analysed first. Excavation and investigation of the PAD that lies outside of Stage 1 is proposed at a later stage.
- The indicative location of the proposed test pits is shown in Figure 2, and their position within the overall proposed development is shown in Figure 3.
- The first test pit will be excavated in 5cm spits (arbitrary units), with the remaining pits excavated in 10cm spits, depending on the characteristics of the first test pit.
- The test pits will be excavated to the maximum depth of impact or until the B Horizon or culturally sterile soil is encountered (that is, at least 20cm below spits from which Aboriginal objects were recovered).
- Excavation will cease if there is any safety concern, including, but not limited to, water ingress, or instability of surrounding soils. An assessment will be conducted to identify if excavation can safely continue, or if test excavation units should be combined to a 1m x 1 m test pit to achieve the required depth, but noting pit counts would be on the basis of 50cm x 50cm squares so a 1 x 1 m area would equate to 4 pits in the pit count.
- The soils will be excavated using hand tools and sieved using a 5mm aperture sieve. In areas of clay dominated soils, wet sieving may be required.
- Test excavation units will be recorded using photographs, scale drawings and written descriptions of soil profiles.
- The test pits will be backfilled as soon as is practicable.
- The test excavation will cease if suspected human remains are encountered, or if enough information has been recovered to adequately characterise the site with regard to its nature and significance (noting that the Code of Practice limits test excavation to 0.5% of the site).
- Attributes of Aboriginal objects (stone artefacts) recovered during test excavations will be recorded, including raw material, colour, reduction type, identification of core/tool, core type, platform type, termination type, length, width, thickness, cortex and weight.

- Excavation procedures and protocols, including the location of test excavation units, may be modified by the Excavation Director in consultation with RAPs and proponent in response to field conditions and requirements.

The results of the test excavation will be used to update the ACHA report and inform the AHIP application. A draft copy of the report will be sent out for review, prior to finalisation.

Proposed Timeline

An indicative timeline for completion of the ACHA is set out below.:

- Presentation of project information and proposed ACHA methodology for review (this document) – early January
- End of review period – early February
- Field investigation – TBC
- Provision of draft ACHA report for review – 4-6 weeks from Field Investigation
- Finalisation of ACHA report – Four weeks from Draft ACHA

Given the Consent Authority's assessment of the application is only quite preliminary, it is proposed to defer field investigations (and subsequent updates of the ACHAR) until there is more certainty on the extent of disturbance that will likely be approved

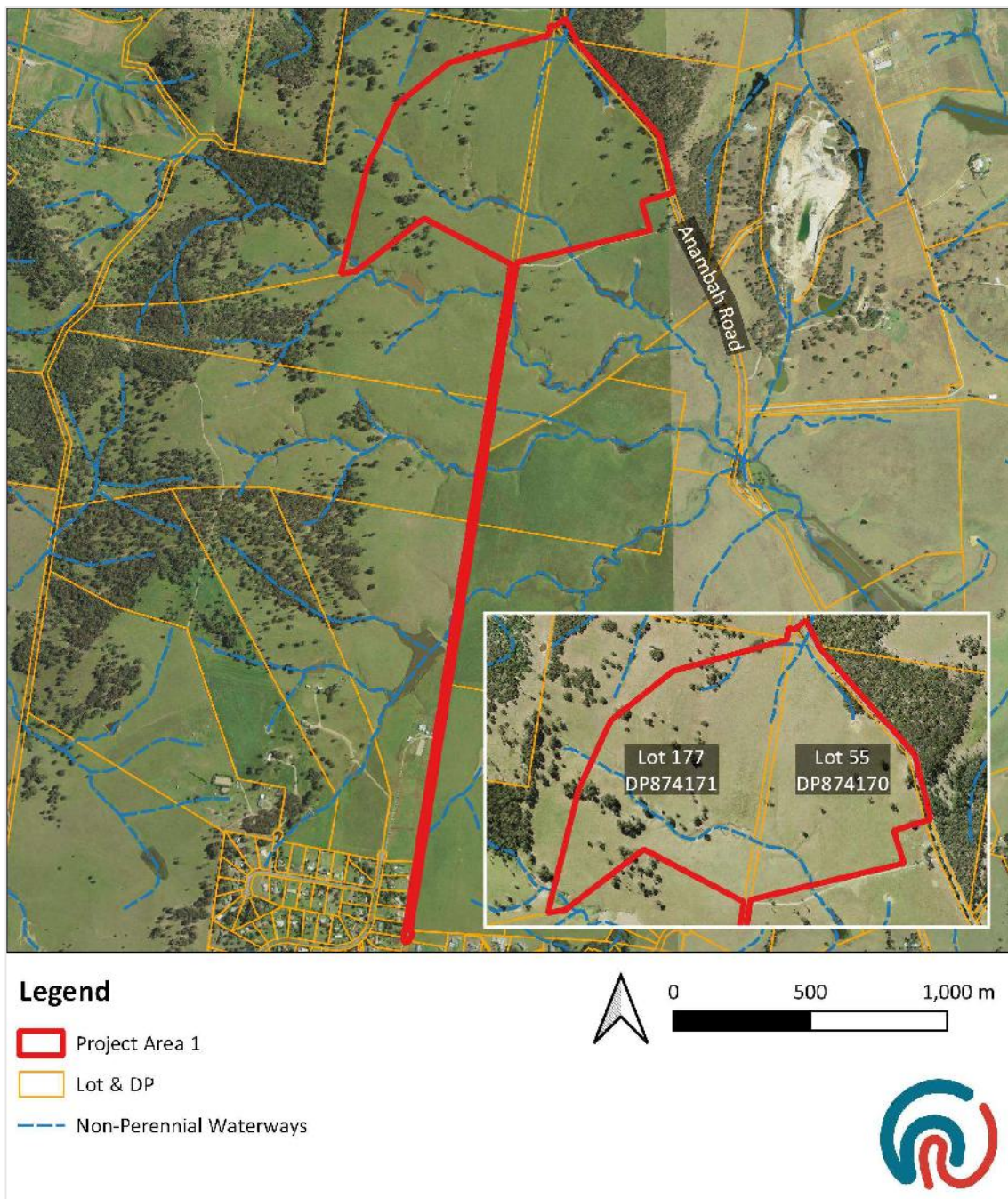


Figure 1 – Aboriginal Cultural Heritage Assessment – Project Area

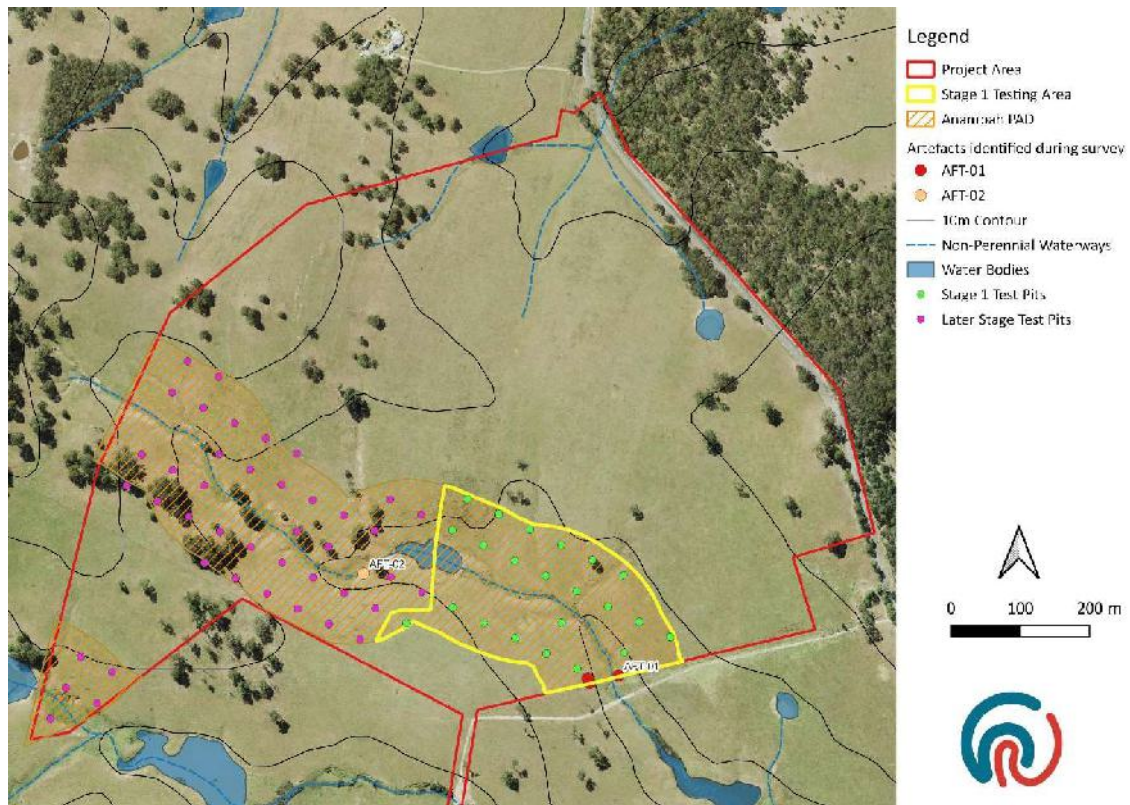


Figure 2 – Indicative location of proposed Aboriginal archaeological test pits

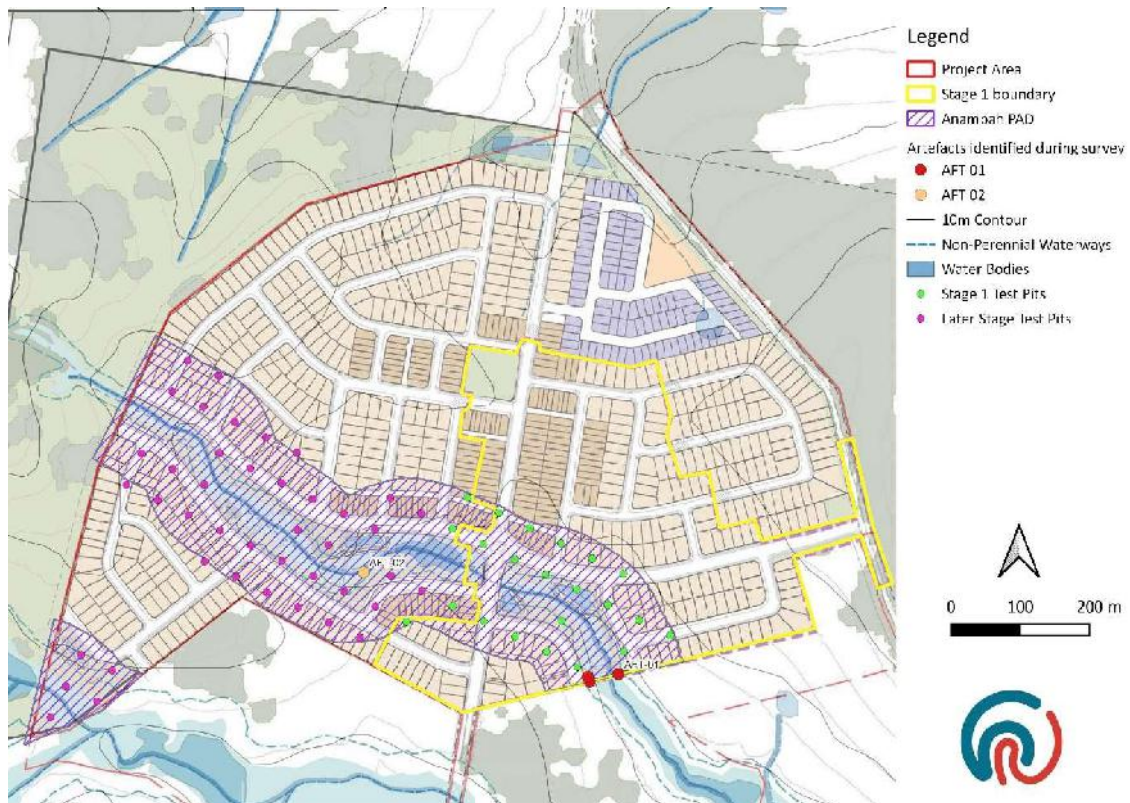


Figure 3 – Indicative location of proposed Aboriginal archaeological test pits, overlaid with proposed lot boundaries

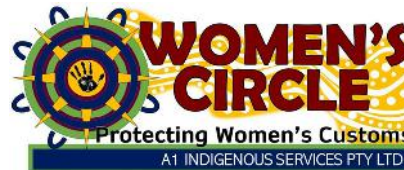

Heritage Now has been engaged by the Thirdi Anambah Pty Ltd (the Proponent: Thirdi Anambah Pty Ltd, 53 Hume Street, Crows Nest NSW 2065) to undertake an ACHA report and preparation of test

excavation methodology addressing a proposed residential development at 559 Anambah Road, Gosforth

The methodology below was provided to the RAPs on 17 January 2025 with 28 days provided for comment. All comments received supported the test excavation methodology. It is noted, that since the methodology was sent, the impact footprint of the stage 1 works has reduced, which has subsequently reduced the number of test pits. However, the overall methodology has remained the same.

Archaeological Background

Heritage Now and Mindaribba Local Aboriginal Land Council completed archaeological survey of the Project Area in December 2023. Two surface artefact sites were identified next to the creek line running through the middle of the study area (Anambah AFT-01 and Anambah AFT-02), and this entire creek line, and the 2nd order creek in the south-west corner of the study area, were assessed as being archaeologically sensitive, with potential for subsurface archaeological material (Anambah PAD). The area of PAD will be impacted by the proposed development, therefore test excavation was recommended by Heritage Now.

Heritage NSW provided a Request for Further Information on 17 October 2024, requesting the ACHAR includes further information to support the development application, namely:

- Consultation records for Appendix 1
 - Consultation records will be compiled with the completed ACHA and Test Excavation Report, it will include log of Aboriginal consultation including emails and phone calls, as well as documentation of correspondence, copies of emails and etc.
- Archaeological survey methodology
 - The ACHA will be updated to include further information on the survey methodology
- Archaeological test excavation methodology and results
 - Heritage Now will complete an excavation based on the methodology provided below. This methodology and the results will be included in the updated ACHA and Test Excavation report
- Additional mapping and figures
 - Additional maps will be inserted with the most current and up to date plans of the Project
 - Maps updated to show the AHIMS number registrations of the sites in the Project Area
 - Proposed AHIP map extent (if AHIP is required)
 - Significance assessment table
 - Impact assessment table
- Revisions required to the Aboriginal Cultural Heritage Assessment Report to comply with guidelines and legislative requirements. A copy of the response from Heritage NSW is attached.

Proposed Methodology

The amended ACHA report will be prepared in accordance with the following guidelines:

- *Guide to investigating, assessing and reporting on Aboriginal cultural heritage in NSW* (Office of Environment and Heritage 2011)

- *Code of practice for archaeological investigation of Aboriginal objects in New South Wales* (Department of Environment, Climate Change and Water 2010)
- *Aboriginal cultural heritage consultation requirements for proponents 2010* (Department of Environment, Climate Change and Water 2010)

The report will include the following:

- a description of the Aboriginal objects located within the area of the proposed activity;
- a description of the cultural heritage values, including the significance of the Aboriginal objects and declared Aboriginal places, that exist across the whole area that will be affected by the proposed activity and the significance of these values for the Aboriginal people who have a cultural association with the land;
- documentation of Aboriginal consultation in accordance with Section 60 of the National Parks and Wildlife Regulation 2019;
- documentation of the views of those Aboriginal people regarding the likely impact of the proposed activity on their cultural heritage;
- documentation of actual or likely harm posed to the Aboriginal objects from the proposed activity, with reference to the cultural heritage values identified; and
- practical measures that can be taken to protect and conserve those Aboriginal objects;
- practical measures that may be taken to avoid or mitigate any actual or likely harm, alternatives to harm or, if this is not possible, to manage (minimise) harm.

Test Excavation Methodology

An archaeological test excavation will be undertaken across the Stage 1 area only to determine whether subsurface Aboriginal objects are present within the proposed impact area and to characterise the Aboriginal objects and deposits. The current scope for the test excavation is limited to the extent of Stage 1 only because, although the ACHAR was prepared for the entire Concept Masterplan, s4.22(5) of the EP&A Act only requires the Consent Authority to consider the likely impact of the carrying out of development. In this instance the likely impact of carrying out the development for subsequent stages will be considered as part of subsequent development applications for those stages. The investigation will be carried out in accordance with the archaeological test excavation methodology provided below, and Requirement 16a of the *Code of Practice for Archaeological Investigation of Aboriginal Objects in NSW*:

- The test excavation will involve hand excavation of test pits located in 50m intervals on a systematic grid across the Anambah PADs, with adjustments to avoid placing pits directly in the creek line. The grid has been orientated to be in line with the creek, to be able to test distance from the water, and if there is any correlation between artefact density and distance from the water.
- If a significant amount of archaeological material is uncovered during testing, additional pits may be placed within the grid, in consultation with Aboriginal stakeholders
- The test excavation will be conducted in multiple stages, with the test pits within the Stage 1 earthworks to be excavated and analysed first. Excavation and investigation of the PAD that lies outside of Stage 1 is proposed at a later stage.
- The indicative location of the proposed test pits is shown in Figure 2, and their position within the overall proposed development is shown in Figure 3.
- The first test pit will be excavated in 5cm spits (arbitrary units), with the remaining pits excavated in 10cm spits, depending on the characteristics of the first test pit.

- The test pits will be excavated to the maximum depth of impact or until the B Horizon or culturally sterile soil is encountered (that is, at least 20cm below spits from which Aboriginal objects were recovered).
- Excavation will cease if there is any safety concern, including, but not limited to, water ingress, or instability of surrounding soils. An assessment will be conducted to identify if excavation can safely continue, or if test excavation units should be combined to a 1m x 1 m test pit to achieve the required depth, but noting pit counts would be on the basis of 50cm x 50cm squares so a 1 x 1 m area would equate to 4 pits in the pit count.
- The soils will be excavated using hand tools and sieved using a 5mm aperture sieve. In areas of clay dominated soils, wet sieving may be required.
- Test excavation units will be recorded using photographs, scale drawings and written descriptions of soil profiles.
- The test pits will be backfilled as soon as is practicable.
- The test excavation will cease if suspected human remains are encountered, or if enough information has been recovered to adequately characterise the site with regard to its nature and significance (noting that the Code of Practice limits test excavation to 0.5% of the site).
- Attributes of Aboriginal objects (stone artefacts) recovered during test excavations will be recorded, including raw material, colour, reduction type, identification of core/tool, core type, platform type, termination type, length, width, thickness, cortex and weight.
- Excavation procedures and protocols, including the location of test excavation units, may be modified by the Excavation Director in consultation with RAPs and proponent in response to field conditions and requirements.

The results of the test excavation will be used to update the ACHA report and inform the AHIP application. A draft copy of the report will be sent out for review, prior to finalisation.

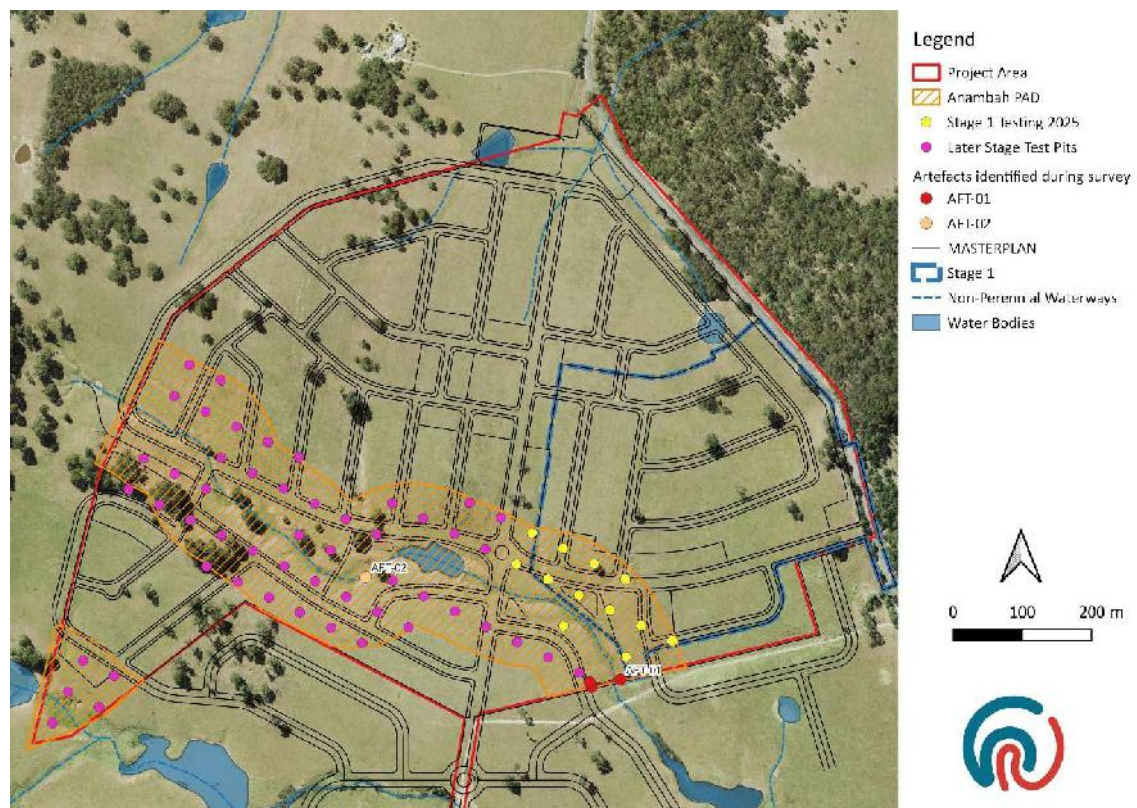


Figure 1 – Location of Project Area

Thank you for the chat earlier.

As we discussed, we will excavate the first transect either side of the creek line with 25 m spacing. If little is found in this first transect, we will proceed with 50 m spacings in the transects further from the creek line. If a significant amount of material is found, we will continue with the 25 m spacing, in consultation with the RAPs. This has brought the minimum number of pits from 12 to 19.

Thank you for notifying Heritage NSW of the intention to undertake test excavations at 559 Anambah Road, Gosforth. Heritage NSW has reviewed the testing methodology and requests further clarification on the following:

- The test excavation methodology states that test pits will be spaced at 50 metre intervals. The Code states that "Test excavation units must be placed on a systematic grid appropriate to the scale of the area – either PAD or site – being investigated e.g. 10 m intervals, 20 m intervals, or other justifiable and regular spacing." Please provide justification as to why test pits are being placed at 50 metre intervals as there are concerns that this will not allow for sufficient archaeological investigation of areas of archaeological sensitivity.
