BRIEFING MATTER

PPSNTH-123 – Gwydir– DA 34/2021 – 5535 North Star Road, North Star – Extractive Industry - 490,000 tonnes per year for a period five (5) years to service the Inland Rail Project and associated road upgrade projects and then a maximum of 150,000 tonnes per year for a period of ten (10) years to service the general market in the local area

KEY ISSUES DISCUSSED

- Overview of project provided being an extractive industry 490,000 tonnes/pa for 5 years and 150,000 tonnes/pa for 10 years
- Key issues include
 - o Vegetation removal additional information requested for BDAR
 - Quarry proximity to lot boundary buffer required, particularly to the east (noting owner interests in the neighbouring property)
 - Haulage roads are being utilised by 2 other 500,000 tonne quarries (other than Minilya Road) cumulative impacts to addressed
 - o Dust suppression not addressed in application
 - Water source for dust suppression details required (including an alternative supply to sediment ponds). Water from existing onsite bore will require a licence change.
- Large separation distances from sensitive receptors (dwellings)
- EPA have issued GTAs, including hours of operation
- Bushfire prone area to be considered in the assessment report, including an Operational Management Plan
- Distance from creek clarified

- Low Capital Investment Value identified on the application noting the scale of the development
- TfNSW additional information to be requested regarding the haulage route intersections design, capacity and any required upgrade
- Traffic on local roads to be considered in the assessment report
- Consultation with Moree Plains Shire Council regarding road contributions to be undertaken and outlined in the assessment report
- Engineering services comments required, including road contributions (being equitable with existing developments)
- Road safety and maintenance to be assessed, including dust control along the road, noting the utilisation of haulage roads by other operators
- Blasting and proximity to the property boundary assessment report to include consideration of fly
 rock. A blast management plan is required to set out procedures for safety, including consideration of
 the adjoining Lot 11 and its possible inclusion if appropriate measures are unable to be provided
- Cumulative impacts (on and off site) to be identified and management measures outlined
- Rehabilitation Plan to be outlined in the assessment report, including measures to ensure works are undertaken at the cessation of the development
- Additional information to be requested, including keys issue impacts and blast management
