PPSNTH-163 – Moree Plains – DA2022/39 - 17339 Newell Hwy and Terry Hie Hie Road, Moree - Establishment of gravel quarry on the property 'Island Paddock'

KEY ISSUES DISCUSSED

- Unauthorised existing operation on the site to be outlined
- Site location outlined, including proximity to the Inland Rail route and Moree
- Proposal outlined as
 - o 130,000 t/pa over 30 years
 - o 20ha extension to existing quarries
 - Upgrade to existing site access from Newell Highway
 - o Removal of topsoil for rehabilitation
 - o Establishment of bunds around development footprint
 - o No blasting or onsite processing
- Proposal clarification required as application notes extension of existing unauthorised operations
- Local demand for gravel product due to the Inland Rail construction and Special Activation Precinct establishment
- Exhibition completed, with no submissions
- Referrals sent to:
 - RFS outstanding
 - ARTC no objection (condition noting any blasting notification, rail crossings to be reduced from 2 to 1 and any works requiring concurrence)
 - TfNSW requested revised Traffic Impact Assessment and Level Crossing Feasibility Study

- o DPI Ag no objection (recommended conditions to minimise land use conflict)
- EPA further information requested on groundwater assessment and updated Operational Environmental Management Plan
- o BCS investigation into historic land use clearing procedural no previous issues identified
- Noise nearest neighbour approximately 1 km, ground level operation proposed with overburden able to be utilised for noise mitigation
- Dust no crushing proposed with water suppression to be applied to trafficable areas
- Traffic haulage route to incorporate turning lanes onto the Newell Highway
- Additional information provided by the applicant is yet to be reviewed

Panel Comments

- Clarification of proposed development required
- Water management and potential impacts on water aquifer to be identified, noting distance from the Gwydir River
- Rehabilitation to form part of the application and to be considered for the whole site
- Rehabilitation plan to specify the future agricultural use, which should be similar to the existing use
- Traffic management plan required and to include assessment of impacts on school buses and the required highway intersection works
- Limit in extraction operations to be imposed
