KEY ISSUES DISCUSSED

- Background outlined, including planning proposal for 'Arcadia' urban release area and structure plans.
- Development proposal outlined as western part of 'Acardia' precinct, noting lodgement of development application for eastern part of 'Acardia' precinct within the next couple of weeks
- Internal and external referrals undertaken outstanding referrals:
 - Transport for NSW, DPIE Environment, Energy & Science (Biodiversity), NSW Rural Fire Service, Heritage NSW
 - o Engineering, Environment & Health, Sport & Recreation, Development Contributions
- Separate development application for early works on Duri Road road and stormwater drainage subject to funding
- Cumulative traffic assessment to be undertaken, with ongoing discussions with TfNSW
 - Speed limit on Duri Road and proposed intersection works amendment from roundabout to T-intersection
- Variations proposed to minimum lot sizes, with insufficient justification being provided
- Size and dimensions of proposed commercial area size being inconsistent with structure plan
- Western freight link and access off Burgmanns Lane, noting the implementation of the R2 land zoning to reduce density and potential for road noise impacts
- Future medium density development proposed on 14 englobo allotments to include variety of lot sizes for housing diversity, noting additional information requirement to demonstrate future development capability
- Site hazards include flooding (Burkes Gully and overland flows) and bushfire

- Precinct density capped and linked to sewer network capacity
- 2 requests for additional information sent, with first response expected within the next week
- Overland flow from Burkes Gully area and proposed onsite stormwater detention basins
- Water supply constraints in south-west corner of 'Arcadia' west area as above contour line
- Biodiversity
 - o Tree removal over the site and protection of the creek line
 - o Additional surveys completed
 - o Ecological communities located on northern part of the site to be protected
 - o Impacts on Burkes Gully area to be assessed if proposed to be utilised for open space
- Community open space
 - District and regional parks to be provided, with Council to be satisfied in regard to amount of open space being provided
 - o Proposed facilities and embellishments to be identified
