Our North Eastern Zone teams in the Northern Rivers have been working hard and the Yamba Sector of the Clarence Valley Flood Emergency Sub Plan has been updated and was tabled recently at the LEMC on Monday 26 Febraury 2024. Volume 3, Chapter 2: Clarence Valley NSW SES Locality Response Arrangements includes Yamba Sector on page 47. Evacuation triggers on page 8 of the BMT West Yamba Flood Evacuation Plan are consistent with the Local Flood Emergency Sub Plan Yamba Sector.
