KEY ISSUES DISCUSSED

- Development outlined, including site footprint
- Redesign of 3 units to enable solar access to living areas

- Site is partially flood prone, with buildings located clear of this area
- Site security planning and arrangements
- Public transport services
- 1 Submission – increased traffic, access, lack of kerb/gutter/footpaths, development by a non-local company
