KEY ISSUES DISCUSSED

- Update on progress of application, noting that an appeal has been lodged:
 - S.34 Conciliation conference held
 - Applicant to provide response by mid-August, with Council to provide a response by end of August and conciliation to recommence on end of August
- Application has not been amended to date, noting potential re-notification
- Biodiversity
 - Impact of development footprint and layout on threatened species and request for revised BDAR
 - Fencing adjacent to C3 zone management of domestic animals and uncontrolled pedestrian access to conservation land
 - \circ $\;$ Location of vehicle wash bay and potential introduction of invasive species
 - Proposed boundary fencing
- Flood assessment -
 - Updated 2022 Flood Model and planning
 - Finished floor level community building and dwellings, Flood Planning Levels (including Probable Maximum Flood level)
 - Clarence River flood behaviour, tidal influences

- o Evacuation, emergency response plans requested
- Shelter in place essential services disruption, policy position, noting proposed occupation
- Other matters include:

- o Urban design pedestrian connectivity/facilities and landscaping
- $\circ~$ Geotechnical consideration of suitability of dredge material
- Traffic impacts consideration of external works and whether proposal can standalone without works; access and traffic capacity of existing and proposed road network
- Stormwater management
- $\circ~$ Filling of land impacts associated with filling of large area
- Landscaping and connectivity
- Proposed increase in amount of fill
 - Source of the fill and traffic impacts
 - Distribution on site and interaction with flood planning (fill footprint/height and development footprint)
 - Cumulative flood impacts
 - Connectivity to other sites in urban release area
 - Draft Development Control Plan
- Outstanding Request for Information
- Car parking requirements, noting additional parking for recreational vehicles
- Concurrence from electricity supplier required
- Staging and construction of community facilities to be confirmed
