- Overview of the proposal and progress of draft amended conditions
- Crown development requiring applicant (NSW RFS) approval of draft conditions prior to determination
- Draft Condition requirement for Road Safety Audit -
 - Proposed development traffic considered to be within road classification levels of service for existing road network, with no upgrades identified by Council's engineering staff
 - No future works identified in works program for subject roads
 - o Increased heavy vehicle movements identified in construction phase of development

- Draft condition noting audit outcomes identified for construction phase to be implemented by applicant, with any ongoing road maintenance works to be undertaken by Council
- Request to reference to the <u>implementation</u> of findings of road safety audit into draft conditions
- \circ $\$ Independent auditor to undertake road safety audit
- Wastewater management consultants report required from applicant in draft conditions, noting proposed removal of reference to lodgement of s68 application
- Fuel storage issue of potential swept path conflicts from vehicle entry discussed, with assessment noting an improvement on existing situation resulting from the proposed one-way traffic flow
- Contamination validation of remediation to be provided to Council, together within the notification of any unexpected finds for asbestos
- Final set of conditions to be issued today, peer reviewed and signed off by applicant prior to probable electronic determination of the application by the Panel
