KEY ISSUES DISCUSSED

- Proposal outlined as an electricity generating facility (solar farm) and future battery energy storage system (BESS) for use in conjunction with existing coal mine
- Site contains mapped biodiversity area, with consideration of fencing to protect area •
- Aboriginal heritage -
 - 3 sites along the eastern boundary will be avoided
 - 5 sites within the development site unavoidable impact and AHIP required 0
 - Consultation undertaken with Aboriginal groups 0
- Site contamination Preliminary Site Investigation did not recommend a Detailed Site Investigation as not a sensitive use
- Site not identified as being subject to flooding, with infrastructure to be located above shallow sheet • flows
- Visual impact no landscaping proposed due to locational characteristics of the site, noting proximity of nearest dwelling not associated with the development and distance from public road
- Noise existing surrounding cumulative noise pollution •
 - Levels at existing dwellings not provided
- Emergency access road consideration of impact on existing site (staff) houses

Panel Comments

- Battery installation and need to avoid impact of flooding on this infrastructure at Probable Maximum Flood level
- Consideration of a safe work protocol with regard to site contamination
- Decommissioning and rehabilitation timeframes noting associated mine operational life
 - Uncertainty re continuity of solar farm activity post mine operations, noting landscaping proposed
 - Consideration of property title to be notated with any consent requirements for decommissioning
- Preliminary hazard assessment not provided in relation to existing dwellings within close proximity additional information to be requested or partial approval to be issued excluding BESS
- Future battery storage risk to existing dwellings as a result of battery facility
 - Options to accept a condition to demolish existing staff dwellings or provide measures to reduce risk
 - Applicant to confirm preference
- Clarification requested in regard to the footprint of mine rehabilitation plan and proximity to development site, also check whether there are any biodiversity offset undertakings affecting the subject property.
