#### **MATTER DETERMINED**

**PPSSCC-271 - SPP-21-00008 – Blacktown - 201 Power Street, Glendenning -** Construction of industrial development comprising 10 warehouses and distribution centres.

### PANEL CONSIDERATION AND DECISION

The Panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings listed at item 8 in Schedule 1.

## **Development application**

The Panel determined to approve the development application pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

### **REASONS FOR THE DECISION**

The Panel determined to approve the application for the reasons outlined in the Council Assessment Report, including matters raised by the Panel at its meeting on 23 November 2021. These matters included:

- Tree planting to address proposed tree removal, and replacement consistent with requirements of the Blacktown Development Control Plan 2015
- Screening for retaining walls and warehouses
- Proximity to the Western Sydney Parklands and the related importance of maintaining vegetation corridors in proximity of the parklands.
- Reduction of the heat island effect.

In addition, key issues that have been addressed in the Council Assessment Report include:

- Drainage and flooding
- Traffic and access
- Hours of operation.

### **CONDITIONS**

The development application was approved subject to the draft conditions in the Council Assessment Report (attachment 7) with the addition of **Condition 18.15.1** (below) that is required to be addressed **Prior to Occupation Certificate**:

# 18.15 Other Matters

**18.15.1** The applicant is to produce the Dexus Drivers' Code of Conduct that will be attached to all leases associated with the site. This Code of Conduct is to include strict safety rules for all heavy vehicle drivers travelling to and from the site using Rooty Hill Road North in proximity of school zones at all times.

In coming to its decision, the Panel notes that no written submissions were made during the public exhibition and therefore no issues of concern were raised.
