DISCUSSION

- The applicant introduced the development for the construction of a 36 storey mixed use building for retail/commercial/residential development. A design competition has taken place.
- The applicant noted that overshadowing of Experiment Farm was a key consideration of the application.
- Council advised that a stop-the-clock RFI has been issued with regard to site boundary clarifications and architectural design among other issues. The applicant noted the site DP arrangements were complicated by a creek having been converted to a stormwater culvert over time.
- Council also observed that the proposal allowed for basements into land dedicated for LRA, which would need to be resolved.
- Council noted that the proposal was subject to the 'satisfactory arrangements' clause under the LEP, which will need to be addressed.
- Council advised that TfNSW has requested additional modelling, as has been the case for multiple sites. Council is seeking to address this as a systemic issue.
- Council is yet to undertake its full assessment. As such this record is not a final list of issues to be considered in drafting a recommendation.
- Council observed that the public exhibition is still in progress; no submissions have been received to date.
- The application is yet to be fully considered by the Sydney Central City Planning Panel and therefore future comment will not be limited to the detail contained within.
