Chair reviewed attendance and introduced Preliminary Briefing purpose and process.

## Applicant

- The applicant advised that an RFI has been received. Matters raised include:
  - o Waste management
  - o Traffic
  - o Trees and Landscaping

## Council

- Council confirmed that they have provided an RFI to the applicant and noted their commitment to working with the applicant to assist in reaching resolution of outstanding matters. The applicant's response is due by 19 November 2023.
- Application has been referred to TfNSW awaiting response.
- Notification concluded less than 10 submissions received.

#### Panel

- The Panel chair outlined the Panel's role in the RSDA process and advised that the Panel does not arbitrate in negotiations between Council and the Applicant on issues raised during the assessment, including in relation to internal and external referrals.
- The panel targets determination of RSDAs within 250 days. The chair recommends that the applicant expedite their efforts to facilitate amendments or additional information required by Council to allow them to complete their assessment. The panel may determine development in the form it is presented at or prior to 250 days.

#### Note:

Council is yet to undertake its full application assessment, so this record is not a final list of the issues they will need to consider in order to draft their recommendation.

The application is yet to be considered by the Sydney Central City Planning Panel and therefore future comment will not be limited to the detail contained within.
