We have undertaken a tender assessment taking into account the following mandatory criteria and scoring based on the selection criteria.

Mandatory Criteria:

Selection Criteria (respective weighted scores):

- Price (30%)
- Extent of conformity, technical and commercial compliance with RFQ (15%)
- Quality of workmanship, past performance & experience in meeting the contract requirements (30%)
- Assessed capacity to perform the work including technical, managerial and physical resources to be applied to the contract & assessed financial capacity to perform the Contract (20%)
- Work heath and safety, quality and environmental management systems and performance (5%)

At the completion of the tender evaluation, Bitzios Consulting was ranked first in the weighted scores. As per the MoU, I will await for your comments prior to contacting all consultants who provided a quote.
