- Public exhibition occurred late December 2021 and one objection received.
- Council is yet to undertake a complete assessment of the application.
- The application is yet to be considered by the Sydney Eastern City Planning Panel.
- Future comment will not be limited to the detail contained below.

Applicant

- Applicant introduction to the proposal:
 - Briefly discussed background, planning controls, description of the proposal and site context.
 - The overall intent of the proposed modifications is to delete Condition 55 and amend Condition 56 in relation to implementation of the Automated Waste

Collection System within the Site which is deemed unfeasible and impractical to the operation of the approved development. Traditional bin waste disposal is requested.

- Reasons for Request:
 - Spatial limitations: additional space required for internal pipes network, loading docks for trucks etc make it cost prohibitive.
 - o Operational limitations:
 - System supplier doesn't recommend the system be installed.
 - Attendance frequency of the vacuum trucks would be similar to traditional trucks.
 - System would only be applicable for residential i.e. commercial would still need tradition bin infrastructure / waste trucks to come to the site.
 - Organic waste disposal chutes not practical due to odour, hygiene and cleaning and frequency of removal issues.

Council

- New DCP control (adopted by Council November 2020) requires Automated Waste Collection System in the K2K area. Detailed justification would be required to support a request to not provide the required waste disposal system.
- Has been referred to external waste consultant expecting a response within 3-4 weeks.
