## **KEY ISSUES DISCUSSED**

- Peer Review of Traffic Impact Assessment undertaken
- Report scope outlined:
  - Peer review
  - 3 site inspections during school drop-off and pick-up times
  - $\circ$  Analysis of worst-cast queuing to determine queue length during the typical school pick-up
  - o SIDRA network modelling
  - Review of proposed Block B car park
  - Dual pick-up/drop-off locations
  - o Green Travel Plan
- Minor issues identified in relation to the internal car park and operational matters
- Queuing assessment noted queuing does not currently reach Franklin Street
- Future school and local population increases may reach Franklin Street, if no other mitigation measures implemented
- Block B car park recommended adjustment to internal car parking spaces to improve the movement of B99 vehicles
- 2 drop-off/pick-up locations not necessary

- Updated traffic survey recommended
- Future analysis noted mitigation options, including:
  - Queuing in Car park Block B
    - o Green Travel plan
    - o Identification of specific locations for staff parking
    - Map of bus stops near school
- Average delay and level of service to increase by up to 5 seconds in future, resulting in a change to Level of Service E for Bunnerong Road/Franklin Street/ Perry Street
- Travel targets identified, including preparation of a Tansport Access Guide, School Bus Services outlined on enrolment, School Transport Coordinator appointment, provision of updated travel survey, cycling initiatives, Annual Plan reviews
- Council traffic engineers to review the report and student numbers to be identified current and projected

**Panel Questions** 

- Minor matters identified in report to be incorporated into the development documentation, following consultation with school
- Future plans for the area and any impacts on Norfolk Lane notation of Matraville DCP, streetscape masterplan and continuation of use of Norfolk Lane and car park
- Acknowledgement of the school appointing a School Transport Coordinator
- Green Travel Plan to be discussed with school and consideration of where people live, opportunities for walk/ride to school day and end of trip facilities
