MATTER DEFERRED

PPSSEC-214 – DA 2022/16 – Burwood - 47A Wentworth Road & 3-5 Everton Road, Strathfield, Alterations and additions to Strathfield Private hospital for the demolition of the existing dwelling at 47A Wentworth Road, tree removal and the construction of a 3 storey building containing basement and ground level parking, 13 additional beds, 2 operating theatres and ancillary services (as described in Schedule 1).

REASONS FOR DEFERRAL

The Panel defers determination of this matter to allow the Applicant the opportunity to submit additional information to address the question of site isolation for the adjoining sites at 1 and 1a Everton Road. This is to include a building envelope as to the maximum potential for these adjoining sites having regard to the overshadowing and the built form of the hospital extension.

The Applicant is to provide the additional information to Council within 2 weeks from the date of this deferral record. If the additional information from the applicant is not provided within 2 weeks, the Panel may move to determine the DA based on the information currently at hand.

Council is to provide a copy of the additional information to the adjoining property owners and their consultant and provide an opportunity for written submissions. The matter is to be referred back to the Panel in a timely manner with a supplementary report and an amended draft set of conditions from Council. The Panel will then electronically determine the matter.

The decision to defer the matter was unanimous. The Panel adjourned during the meeting to deliberate on the matter and formulate this resolution.
