MATTER DETERMINED

PPSSEC-290 – Strathfield – DA2017.64.6 – 63-65 Cosgrove Road, South Strathfield – S4.55(2) Modification Application to extend working hours to enable 24/7 operation (as described in Schedule 1).

PANEL CONSIDERATION AND DECISION

The Panel considered the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings listed at item 8 in Schedule 1.

Application for modification of consent

The Panel is satisfied that the application is substantially the same development and the reasons for the original approval have been taken into consideration for this determination.

The Panel is satisfied that the modification warrants approval on a merit assessment and determined to approve the application.

The Panel determined to approve the modification application pursuant to section 4.55(2) of the *Environmental Planning and Assessment Act 1979*.

The decision was unanimous.

REASONS FOR THE DECISION

The Panel determined to approve the modification application for the reasons outlined in the Council Assessment Report and the additional information provided by the applicant with respect to truck movements and current annual through put tonnage.
