PPSSEC-301 – Bayside – DA-2023/345 – 125, 127 & 131 Baxter Road, Mascot – Integrated Development - Tree removal, demolition of existing structures and construction of an eleven (11) storey building comprising tourist and visitor accommodation, one (1) level of basement car parking, two (2) levels of above ground car parking, food and drink premises at ground floor and Level 11, associated landscaping and business identification signage

## **KEY ISSUES DISCUSSED**

- Location and surrounding development context provided
- Site constraints noted, including location of existing sewer running across the rear of the site and obstacle height limitation
- Proposal outlined, including variation to floor space ratio (856.5 m² surplus GFA 25.9% variation)
- Request for Information sent:
  - Site connectivity and interface with western neighbour access and substation
  - Reports to be updated as current proposal
  - Revised sustainability report for current proposed design required to demonstrate compliance with SEPP
  - Site suitability in regard to contamination to be provided, noting proposed basement level
  - o Lack of signage information Baxter Road elevation
  - Site located near freight rail line, noting duplication of lines and proposed future increase in rail use – acoustic report to be updated
  - o Acid Sulphate Soils Management Plan required and further assessment

- Design excellence not currently supported, with re-referral to DRP required
  - Bulky built form
  - Merge vehicle access/services
  - Continuation of landscaping
  - Avoid cantilever of upper levels
  - Continuous landscaped setbacks
  - Sustainability initiatives to be beyond minimal
  - Loss of street tree not supported
  - Improve interface on western site
  - Introduce natural light/ventilation to communal corridors
  - Refinement of top floor and architectural quality
