PPSSEC-364 – Canada Bay - DA2024/0138 - 2 & 4 Denham Street, Rhodes - Integrated Development under the Water Management Act 2000 for demolition of existing structures (including three (3) existing dwellings), tree removal, construction of a three (3) level basement for 34 car parking spaces, 4 visitor spaces, 68 bicycle parking spaces and eight (8) motor cycle parking spaces, on-site loading bay with turntable for HRV access, construction of 34 dwellings, comprising 30 apartments (including five (5) adaptable apartments) and four (4) multi-dwelling housing (terraces), on-site landscaping, residential amenities and building services

- · Overview of development, site context and location, including Council owned land
- Determination incorrectly determined by the Cananda Bay Local Planning Panel (27 November 2024), as development is identified as regionally significant development
- Background of proposal and outline of assessment process
 - Application lodged 24 July 2024
 - Notification 4 submissions
 - o Canada Bay Design Review Panel did not support the proposal
 - o Applicant requested to withdraw due to significant issues
- Class 1 Appeal filed on 24 September 2024
 - Council's SOFAC filed 22 October 2024
 - Applicant's SOFAC in reply filed 13 November 2024

- Amended plans and documentation submitted subject to a without prejudice discussion at the conciliation conference – 25 November 2024
- Amended plans outlined:
 - Basement footprint reduced
 - Multi-dwelling housing (terraces) removed

 - Loading dock relocated
 - Removal of all works (except from landscaping) across the Council drainage reserve
 - Removal of the wintergardens
