The Panel determined that the proposed modifications are minor and remain consistent with the relevant planning controls which apply to the site.

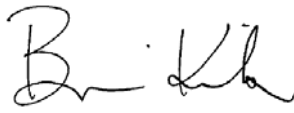
The Panel determined to approve the application for the reasons outlined in the council assessment report.
