MATTER DETERMINED

PPSSNH-160 – Northern Beaches – MOD2019/0627 at Lot 101 Wyatt Avenue Belrose for modification to an approved development application (as described in Schedule 1)

PANEL CONSIDERATION AND DECISION

The panel considered: the matters listed at item 6, the material listed at item 7 and the material presented at meetings and briefings and the matters observed at site inspections listed at item 8 in Schedule 1.

Development application

The panel determined to approve the development application pursuant to section 4.55 of the *Environmental Planning and Assessment Act 1979*.

REASONS FOR THE DECISION

The panel determined to approve the application for the reasons outlined in the council supplementary report.

CONDITIONS

The development application was approved subject to the conditions in the council supplementary report dated 21 December 2020.

CONSIDERATION OF COMMUNITY VIEWS

In coming to its decision, the panel considered written submissions made during public exhibition and heard from all those wishing to address the panel. The panel notes that issues of concern included:

- Inconsistency with the requirements of the C8 Belrose North locality of WLEP 2000;
- Non-compliance with Built Form Controls;
- Adverse impact on surrounding road network;
- Impact on local residential amenity

The panel considers that concerns raised by the community have been adequately addressed in the assessment report and that no new issues requiring assessment were raised during the public meeting.
