**RE: Opal Aged Care Seaside - s4.56 Landscaping Update – ACCESSIBILITY STATEMENT**

This letter has been prepared by Morris Goding Accessibility Consulting (MGAC) to support the proposed s4.56 application for the Opal Seaside Aged Care facility located at 184-194 Garden Street, Warriewood, NSW.

The s4.56 application proposes amendment to the previously approved Development Application for the project that was granted following further design development. The key areas the s4.56 application proposes to make minor layout amendments to the external landscaping layout.

These documents have been reviewed and assessed by MGAC in comparison to original DA design scheme and with respect to the relevant Access Codes and Standards. Following our review, we conclude that in general, the proposed s4.56 design changes can achieve reasonable access provisions for people with disability as set out in the requirements of the DDA Premises Standards, BCA and AS1428 Suite. Ongoing reviews will be done at a construction level stage to ensure full compliance is achieved.
